Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective September 1, 2017?

Procedural History

On August 1, 2017, NYSOH issued a notice of eligibility determination, based on your July 31, 2017 application, stating that you were eligible for Medicaid, effective July 1, 2017.

Also on August 1, 2017, NYSOH issued a notice of enrollment in the plan you selected on July 31, 2017, stating that you were enrolled in a Medicaid Managed Care plan, and that your coverage would start on September 1, 2017.

On August 22, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, insofar as it did not begin August 1, 2017.

On October 31, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on July 31, 2017.
- 2) You testified, and the record reflects, that you selected your Medicaid Managed Care Plan on July 31, 2017, and that your enrollment was effective on September 1, 2017.
- 3) You testified that you want your Medicaid Managed Care plan to begin on August 1, 2017 because you had a gap in coverage.
- 4) You testified your prior Medicaid coverage through your local county Human Resource Administration ended July 31, 2017.
- 5) You testified you had found out your coverage was going to be discontinued in July 2017. You were not sure if you received a notice from the local County directing you to renew your coverage to prevent any lapses.
- 6) You testified you paid a bill out of pocket for the month of August, and submitted it for reimbursement to NYSOH and you have yet to receive a decision on whether it could be reimbursed.
- 7) You reside in [REDACTED]

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Medicaid Managed Care plan was effective September 1, 2017.

You testified and the record supports that you contacted NYSOH on July 31, 2017 and enrolled into a Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On July 31, 2017, you selected a Medicaid Managed Care plan, so it properly took effect on the first day of the second month following July; that is, on September 1, 2017.

You testified that your enrollment in your Medicaid with the local Kings County Human Resources Administration ended on July 31, 2017. You were not sure if you received a notice from the local County directing you to renew your coverage to prevent any lapses.

It is not within the authority of the NYSOH appeals unit to review notices or the proper issuance of notices from local agencies administering benefits under Non-MAGI based Medicaid. It cannot be determined whether proper notice was provided to you of the end date of your Medicaid coverage by the Human Resources Administration of Kings County.

Therefore, the August 1, 2017 enrollment confirmation notice stating your enrollment in your Medicaid Managed Care plan was effective September 1, 2017 was proper and is AFFIRMED.

Decision

The August 1, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

The effective date of your Medicaid Managed Care plan is September 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
