Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Does the Appeals Unit of NY State of Health (NYSOH) have the authority to review the cancellation of coverage for your child for a purported non-payment of premiums?

Did NYSOH properly determine that your child's reenrollment in a Child Health Plus plan was effective October 1, 2017?

Procedural History

On June 23, 2017, NYSOH issued a notice of eligibility determination, stating that your child was eligible to enroll in a Child Health Plus plan, with a monthly premium of \$60.00, effective August 1, 2017.

Also on June 23, 2017, NYSOH issued an enrollment confirmation notice stating that your child remained enrolled in a Child Health Plus plan, effective April 1, 2017.

On August 8, 2017, NYSOH issued a disenrollment notice stating that your child's coverage in his Child Health Plus plan ended effective July 31, 2017, because you did not pay your insurance bill by the payment deadline.

On August 22, 2017, you spoke to NYSOH's Account Review Unit and appealed the end date of your children's Child Health Plus plan.

NYSOH records reflect that you updated your account and selected a Child Health Plus plan for your child on August 24, 2017.

On August 25, 2017, NYSOH issued an eligibility determination notice stating that your child was eligible for a Child Health Plus plan, effective October 1, 2017.

Also on August 25, 2017, NYSOH issued an enrollment confirmation notice stating that your child was enrolled in a Child Health Plus plan, effective October 1, 2017.

On October 24, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing your child's Child Health Plus plan disenrollment effective July 31, 2017 and his Child Health Plus plan re-enrollment date of October 1, 2017
- 2) NYSOH records reflect that your child remained enrolled in a Child Health Plus plan with an effective start date of April 1, 2017.
- 3) You testified that you received an invoice from your insurance carrier for August 2017 but because of some confusion you did not make your premium payment.
- 4) Your child was disenrolled from his Child Health Plus plan, effective August 1, 2017 for non-payment of premiums.
- 5) You submitted an application to NYSOH for financial assistance for your child and he was determined eligible for a Child Health Plus plan on August 24, 2017.
- 6) You testified, and NYSOH records reflect, that you selected a Child Health Plus plan for your child on August 24, 2017.
- 7) Your child's Child Health Plus plan start date was October 1, 2017.
- 8) You testified that you are seeking coverage for your child for the months of August and September 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (4) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The first issue under review is whether the Appeals Unit of NYSOH has the authority to review the cancellation of coverage for your child for a purported non-payment of premiums.

The Appeals Unit of NYSOH only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) a failure by NYSOH to provide timely notice of an eligibility determination, and (4) a denial of a for a special enrollment period.

Because the Appeals Unit is not authorized to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether your child was properly terminated for nonpayment of premiums.

Therefore, your appeal of the August 8, 2017 disenrollment notice is **DISMISSED** as a non-appealable issue.

The second issue under review is whether NYSOH properly determined that your child's enrollment in a Child Health Plus plan was effective October 1, 2017.

You testified, and NYSOH records indicate, that you updated your NYSOH application on August 24, 2017. As a result, your child was found eligible for a Child Health Plus plan on August 24, 2017 and you selected a plan that day.

The date on which enrollment in a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On August 24, 2017, you selected a Child Health Plus plan, so your child's enrollment properly took effect on the first day of the following month; that is, on October 1, 2017.

Therefore, the August 25, 2017 enrollment confirmation notice stating that your child's enrollment in a Child Health Plus plan was effective October 1, 2017, is correct and must be **AFFIRMED**.

Decision

The August 25, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility.

The effective date of your child's Child Health Plus plan is October 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
