Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your children's enrollments in their Child Health Plus plan was effective July 1, 2017?

Procedural History

On May 17, 2017, NYSOH received your children's initial application for financial assistance with their health insurance.

On May 18, 2017, NYSOH issued an eligibility determination notice stating your children were eligible for Child Health Plus at full cost, effective July 1, 2017.

Also on May 18, 2017, NYSOH issued an enrollment notice confirming your children's enrollment on May 17, 2017 in a Child Health Plus plan effective July 1, 2017.

On July 3, 2017, you filed a complaint with NYSOH stating that you would like your children not to have a gap in coverage for the month of June 2017.

On August 25, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin June 1, 2017.

On October 27, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the proceeding that day.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your children's enrollment start date.
- 2) The record reflects the first time an application was submitted to NYSOH for financial assistance with health insurance for your children was on May 17, 2017.
- 3) You testified you went to an Application Counselor in person to submit an application on May 17, 2017.
- 4) You testified you were not sure if you attempted to apply to NYSOH prior to May 17, 2017.
- 5) You testified you were aware your children's coverage was ending with Medicaid through your [REDACTED] and received a letter stating it would end May 31, 2017.
- 6) You testified, and the record supports you enrolled your children into a Child Health Plus plan on May 17, 2017.
- 7) You testified that you need your children's Child Health Plus plan to begin on June 1, 2017 as you had medical bills not covered by for that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

A child who meets the eligibility requirements for Child Health Plus (CHP) may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (New York Public Health Law (PHL) § 2511(2)(a)(iii)). To be eligible to enroll in CHP with subsidy payments, a child must not be "eligible for medical assistance"; that is, must not be eligible for Medicaid (NY Public Health Law § 2511(2)(b)).

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your children’s enrollment in their Child Health Plus plan was effective July 1, 2017.

You testified and the record supports you first applied for financial assistance with children’s health insurance through NYSOH on May 17, 2017. As a result of that application your children were determined eligible for Child Health Plus at full cost starting July 1, 2017. You enrolled your children in a plan that day.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since your children’s application was completed on May 17, 2017, and enrollment was submitted on that day, their Child Health Plus plan would take effect on the first day of the second month following May, which is July 1, 2017.

Therefore, the May 18, 2017 eligibility determination notice and enrollment confirmation notices are AFFIRMED as they properly began your children's eligibility and enrollment in their Child Health Plus plan as of July 1, 2017.

Decision

The May 18, 2017, eligibility determination notice is AFFIRMED.

The May 18, 2017, enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

The effective date of your children's Child Health Plus plan is July 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
