NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On August 29, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to receive and advance payment of the premium tax credit of up to \$239.00 per month. You appealed that determination.

On November 2, 2017, a hearing was held and testimony was received.

According to your NYSOH account, on November 15, 2017, while the record was still open and pending receipt of documentation, you contacted NYSOH and requested that your appeal be withdrawn.

On December 21, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you back and placed you under oath again.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you had been found eligible for the Essential Plan after the appeal was filed and you are satisfied with that eligibility determination.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
