NOTICE OF DISMISSAL – FAILURE TO APPEAR

On September 6, 2017, NY State of Health (NYSOH) issued a notice of enrollment confirmation, stating that you were enrolled in a Medicaid Managed Care Plan, effective October 1, 2017. You appealed this determination.

On September 26, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for October 26, 2017, at 3:00 p.m.

On October 26, 2017 at 3:00 p.m., a Hearing Officer from the Appeals Unit of NY State of Health called you and attempted to conduct your hearing, you confirmed that you wanted to proceed with the hearing, were sworn in and asked if you would like to provide an opening statement but you disconnected the call before giving one. The Hearing Officer placed three additional calls at 3:05 p.m., 3:15 p.m., and 3:30 p.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
