## NOTICE OF DISMISSAL – FAILURE TO APPEAR

On August 11, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to enroll in the Essential plan, effective September 1, 2017. On September 6, 2017, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in the Essential Plan, effective October 1, 2017. You appealed these determinations.

On September 15, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for October 17, 2017, at 9:00 am.

On October 17, 2017, a Hearing Officer placed three calls to you at [REDACTED] at 9:00 am, 9:15 am, and 9:30 am, but was unable to reach you. The Hearing Officer also placed two calls to you at [REDACTED] at 9:01 am and 9:16 am. At 9:16 am an individual answered and advised that you were not present.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
