Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your eligibility for the Essential Plan ended effective August 31, 2017?

Procedural History

On March 17, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan for a limited time, effective May 1, 2017. The notice further directed you to provide documentation confirming your income before June 14, 2017.

Also on May 17, 2017, NYSOH issued a notice confirming your enrollment in an Essential Plan, effective May 1, 2017.

On June 2, 2017, you uploaded a paystub into your account.

On June 3, 2017, NYSOH issued a notice stating that the documentation reviewed did not confirm the information in your application. You were directed to provide additional documentation confirming your income by June 29, 2017.

On June 16, 2017, you uploaded a paystub into your account.

On June 20, 2017, NYSOH issued a notice stating that the documentation reviewed did not confirm the information in your application. You were directed to provide additional documentation confirming your income by July 14, 2017.

On July 11, 2017, you uploaded additional documentation to your account.

On July 13, 2017, NYSOH issued a notice stating that the documentation reviewed did not confirm the information in your application. You were directed to provide additional documentation confirming your income by July 29, 2017.

On August 4, 2017, NYSOH issued an eligibility determination notice stating that you were newly eligible to purchase a qualified health plan at full cost. The notice stated that you were not eligible to enroll in the Essential Plan because NYSOH did not receive the income documentation needed to verify the income listed in your application. This eligibility was effective September 1, 2017.

Also on August 4, 2017, NYSOH issued a disenrollment notice stating that your enrollment in the Essential Plan would end as of August 31, 2017, because you were no longer eligible to remain in your plan.

On September 6, 2017, you updated your application for financial assistance. That day, a preliminary eligibility determination was prepared stating that you were eligible to enroll in the Essential Plan for a limited time and you selected a plan for enrollment.

Also on September 6, 2017, you spoke to NYSOH's Account Review Unit and appealed the termination of your Essential Plan for the month of September 2017.

On September 7, 2017, NYSOH issued a notice of eligibility determination, based on your September 6, 2017 application, stating that you were eligible to enroll in the Essential Plan for a limited time, effective October 1, 2017.

Also on September 7, 2017, NYSOH issue a notice of enrollment confirmation, based on your plan selection on September 6, 2017, stating that you were enrolled in an Essential Plan effective October 1, 2017.

On November 10, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and your NYSOH account confirms, that you receive all of your notices from NYSOH by electronic mail.

- 2) You testified that you did not receive any electronic alerts notifying you of any notice in your NYSOH account stating that the documentation you submitted was insufficient and that you needed to provide additional documentation of your income.
- 3) You submitted income documentation to NYSOH on June 2, 2017, June 16, 2017, and July 11, 2017.
- 4) You testified that you did not know that the income documentation you submitted was insufficient until September 2017.
- 5) Your NYSOH account indicates that on August 3, 2017 your application was run and you were found no longer eligible for the Essential Plan as of August 31, 2017.
- 6) You updated the income information in your NYSOH account on September 6, 2017.
- 7) You testified that you are seeking reinstatement of your Essential Plan for the month of September 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Verification of Eligibility for the Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

NYSOH must verify the eligibility of an applicant for the Essential Plan consistent with the standards set in 45 CFR § 155.315 and § 155.320 (New York's Basic Health Plan Blueprint, pgs. 16-17, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>; 42 CFR § 600.345(a)(2)).

An applicant is required to attest to their household's projected annual income. (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security in order to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant in order to resolve the inconsistency (45 CFR §155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any updates in eligibility to the Essential Plan effective the first day of the following month for changes received by NYSOH from the first to the fifteenth of any month (45 CFR § 155.420(b)(1)(i); *see also* 42 CFR § 600.320(c)). For updates received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR § 155.420(b)(1)(ii); *see also* 42 CFR § 600.320(c)).

Electronic Notices

Applicants may choose to receive notices and information from NYSOH either by electronic alerts or by regular mail. If the applicant elects to receive electronic notices, NYSOH must send an email or other electronic communication alerting the individual that a notice has been posted to the applicant's account (42 CFR § 600.330(e); 42 CFR § 435.918(b)(4)).

Additionally, if an electronic alert regarding a notice in an individual's NYSOH account fails, NYSOH must send out the notice by regular mail within three days of the failed alert (42 CFR § 435.918(b)(5)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your eligibility for the Essential Plan ended effective August 31, 2017.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to his or her household's projected annual income. For individuals seeking enrollment in the Essential Plan, NYSOH must request income data from federal data sources in order to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

In the eligibility determination issued on March 17, 2017, you were advised that you were eligible for the Essential Plan for a limited time, and that you needed to confirm your household's income before June 14, 2017.

The record reflects that you submitted income documentation to NYSOH on June 2, 2017, June 16, 2017, and July 11, 2017, but that NYSOH determined it insufficient. NYSOH issued notices asking for additional income documentation on June 3, 2017, June 20, 2017, and July 13, 2017. These notices also extended the deadline for you to submit income documentation.

However, you testified that you elected to receive alerts regarding notices from NYSOH electronically. You credibly testified that you did not receive an electronic alert regarding your income documentation, which advised you that your documentation was insufficient and that you needed to submit additional documentation to confirm your income. There is also no evidence in your account documenting that any email alert was sent to you regarding the need to submit additional documentation, nor is there any evidence that the notice was sent to you by regular mail.

Therefore, it is concluded that NYSOH did not give you the proper notice that your documentation was insufficient and that you needed to submit additional documentation of your income in order to confirm your eligibility for the Essential Plan.

Since you were not made aware of and did not receive proper notice that there was an inconsistency in your NYSOH account, the August 4, 2017 eligibility determination and August 4, 2017 disenrollment notices, stating that you are no longer eligible for the Essential Plan because you failed to submit documentation are **RESCINDED**.

Your case is **RETURNED** to NYSOH to reinstate your coverage in your Essential Plan for the month of September 2017.

The August 4, 2017 notice of eligibility determination is RESCINDED.

The August 4, 2017 notice of disenrollment is RESCINDED.

Your case is RETURNED to NYSOH to reinstate your coverage in your Essential Plan for the month of September 2017.

How this Decision Affects Your Eligibility

NYSOH erred in terminating your Essential Plan effective August 31, 2017, without the proper notice.

Your case is being sent back to NYSOH to reinstate your coverage in your Essential Plan for the month of September 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
