## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to enroll in the Essential Plan, effective October 1, 2017?

Did NYSOH properly determine that you were not eligible for Medicaid, as of September 6, 2017?

## Procedural History

On August 10, 2017, NYSOH received your updated application for financial assistance.

On August 11, 2017, NYSOH issued an eligibility determination based on the August 10, 2017 application, stating that you are eligible to enroll in the Essential Plan for a limited time with a \$20.00 monthly premium, effective September 1, 2017. The notice directed you to submit documentation to confirm your household income by November 8, 2017.

Also on August 11, 2017, NYSOH issued a notice of enrollment confirmation, confirming your enrollment in an Essential Plan, beginning October 1, 2017.

On August 30, 2017, you uploaded documentation to your NYSOH account.

Also on August 30, 2017, NYSOH redetermined your eligibility for financial assistance.

On August 31, 2017, NYSOH issued a notice of eligibility determination, stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective October 1, 2017.

On September 6, 2017, you updated your NYSOH account. That day, NYSOH prepared a preliminary eligibility determination stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective October 1, 2017.

Also on September 6, 2017, you contacted NYSOH's Account Review Unit and requested an appeal of that eligibility determination, insofar as you were not eligible for Medicaid.

On September 7, 2017, NYSOH issue a notice of eligibility determination, stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective October 1, 2017.

On November 14, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open until November 22, 2017 to allow you to submit supporting documentation.

On November 20, 2017, you faxed documentation to the Appeals Unit. The record is now closed.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim two dependents on that tax return.
- 2) You are appealing on behalf of yourself only.
- 3) The application that was submitted on September 6, 2017, which requested financial assistance, listed annual household income of \$35,000.00, consisting of income you earn from your employment
- 4) You testified that you work 35 hours per week and are paid \$17.00 an hour. You testified that your biweekly paycheck is approximately \$1,200.00, before taxes.
- 5) After the hearing, you faxed a two-page document to the Appeals Unit, consisting of a [REDACTED] from [REDACTED] [REDACTED]. The document showed that you received pay in the amount

of \$1,398.26 on September 8, 2017, and \$1,488.82 on September 22, 2017. This document is marked and entered into the record as "Appellant's Exhibit One."

- 6) Your application states that you will not be taking any deductions on your 2017 tax return.
- 7) Your application states that you live in [REDACTED]
- 8) You testified that you are looking to be eligible for Medicaid instead of the Essential Plan because you are a single mother of two, and it is very difficult to pay your other bills, even without having to pay for health insurance.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$20,160.00 for a three-person household (81 Federal Register 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

### Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$20,420.00 for a four-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

## **Legal Analysis**

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan, effective October 1, 2017.

The application that was submitted on September 6, 2017 listed an annual household income of \$35,000.00, and the eligibility determination relied upon that information.

You are in a three-person household. You expect to file your 2017 income taxes as single and will claim two dependents on that tax return.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is between 138% and 200% of the FPL for the applicable family size.

On the date of your application, the relevant FPL was \$20,160.00 for a three-person household. Since an annual household income of \$35,000.00 is 173.61% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan.

The second issue under review is whether NYSOH properly determined that you were not eligible for Medicaid, as of your September 6, 2017 application.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$20,420.00 for a three-person household. Since \$35,000.00 is 171.40% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

After the hearing, you submitted documentation showing that you received two paychecks in September 2017, and those paychecks added up to a gross monthly income of \$2,887.08.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$2,348.30 per month. Since the documentation you provided shows that you earned \$2,887.08 in September 2017, you do not qualify for Medicaid on the basis of monthly income, as of the date of your application.

Since the September 7, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for the Essential Plan, it was correct and is AFFIRMED.

## **Decision**

The September 7, 2017 eligibility determination notice is AFFIRMED.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
