NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On March 28, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating your spouse was enrolled in an Essential Plan, effective May 1, 2017. You appealed the effective date of that coverage.

On October 27, 2017, NYSOH issued a Notice of Hearing to advise you the hearing you requested was scheduled for November 27, 2017, at 10:00 a.m.

A Hearing Officer called you on the scheduled hearing date. You were placed under oath, identified yourself for the record, and you testified that you were only appealing your spouse's disenrollment from his Essential Plan for the month of April 2017. You testified you were not appealing your own coverage, because you did not have any outstanding medical bills. You were advised by the Hearing Officer that, according to your account, your spouse appeared to be enrolled in an Essential Plan for the month of April 2017. The hearing was adjourned to allow you to contact your spouse's health plan to confirm his enrollment for the month of April 2017. You were advised that the adjourned hearing would commence on December 5, 2017 at 9:00 a.m. in the event the issue was not resolved and you wanted to proceed with the appeal.

On December 5, 2017, the Hearing Officer placed three calls to the telephone number you provided to NYSOH, at 9:00 a.m., 9:15 a.m., and 9:30 a.m., but was unable to reach you.

Since you did not appear for your adjourned hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
