NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On July 1, 2017, NY State of Health (NYSOH) issued an eligibility determination and enrollment confirmation notices, stating that your child was eligible for and enrolled in Child Health Plus effective August 1, 2017. You appealed these notices.

On September 26, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for October 31, 2017 at 3:00pm.

On October 31, 2017, a Hearing Officer called you and began to conduct your scheduled telephone hearing. However, due to issues with your phone you and the Hearing Officer agreed to adjourn your hearing to November 6, 2017 at 2:00pm.

On November 6, 2017, a Hearing Office called you but you stated that you forgot about the adjourned hearing that day and asked that your hearing be adjourned again. The Hearing Officer agreed to adjourn your hearing to November 13, 2017 at 2:00pm but you were advised that this would be the last and final adjournment that would be granted to you.

On November 13, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 2:00p.m., 2:15p.m., and 2:30p.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
