## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On July 19, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for an advance premium tax credit (APTC) of up to \$321.00 per month and, if you selected a silver-level plan for enrollment, eligible for cost-sharing reductions (CSR), effective September 1, 2017.

On July 24, 2017, NYSOH issued a disenrollment notice stating that your health plan coverage ended effective May 31, 2017 due to non-payment of premium.

You appealed these determinations.

On November 9, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your health plan coverage had been retroactively reinstated effective June 1, 2017, and that you would reconcile any non-receipt of APTC when you file your 2017 tax return.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
