Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that your eligibility for the Essential Plan ended effective August 31, 2017?

Did NYSOH properly determine that your eligibility for and enrollment in the Essential Plan was effective October 1, 2017?

Procedural History

On May 8, 2017, NYSOH received your updated application for financial assistance with your health insurance.

On May 9, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan for a limited time, effective June 1, 2017. The notice further directed you to provide documentation confirming your income before August 6, 2017.

On May 9, 2017, NYSOH issued a notice confirming your enrollment in an Essential Plan, effective June 1, 2017.

On August 13, 2017, NYSOH issued an eligibility determination notice stating that you were newly eligible to purchase a qualified health plan at full cost. The notice stated that you were not eligible to enroll in the Essential Plan because NYSOH did not receive the income documentation needed to verify the income listed in your application. This eligibility was effective September 1, 2017.

Also on August 13, 2017, NYSOH issued a disenrollment notice stating that your enrollment in the Essential Plan would end as of August 31, 2017, because you were no longer eligible to remain in your plan.

On August 25, 2017, you updated your application for financial assistance.

On August 26, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan, for a limited time, effective October 1, 2017. The notice further directed you to provide documentation confirming your income before November 23, 2017.

Also on August 26, 2017, NYSOH issue a notice of enrollment confirmation, based on your plan selection on August 25, 2017, stating that you were enrolled in an Essential Plan effective October 1, 2017.

On September 8, 2017, you spoke to NYSOH's Account Review Unit and appealed the termination of your Essential Plan for the month of September 2017.

Also on September 8, 2017, you requested an expedited appeal.

On September 12, 2017, NYSOH received a document from your physician in support of your expedited appeal request.

On September 13, 2017, your request for an expedited appeal was granted.

On September 21, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and your application indicates, that you receive all of your notices from NYSOH via regular mail.
- 2) You testified that you received the May 9, 2017, notice and were aware that you were required to provide income documentation by August 6, 2017.
- 3) No notices that were sent to the address listed on your NYSOH account have been returned as undeliverable.

- 4) You testified you faxed income documentation on or about May 8, 2017, the day you applied over the phone with a NYSOH representative.
- 5) You testified you faxed the income documentation with a bar code associated with your account.
- 6) You testified you received a confirmation page that the fax was sent. You testified that you are no longer in possession of the confirmation page.
- 7) Your NYSOH account indicates that on August 12, 2017, your application was run and you were found no longer eligible for the Essential Plan as of August 31, 2017.
- 8) NYSOH received a verification document from you on August 31, 2017. This is the first instance in the record of their being income documentation submitted since your May 8, 2017 application.
- 9) You updated the income information in your NYSOH account on August 25, 2017.
- 10) You testified that you are seeking enrollment in your Essential Plan as of September 1, 2017.
- 11) You reside in Onondaga County, NY.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Verification of Eligibility for the Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR

§ 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

NYSOH must verify the eligibility of an applicant for the Essential Plan consistent with the standards set in 45 CFR § 155.315 and § 155.320 (New York's Basic Health Plan Blueprint, pgs. 16-17, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>; 42 CFR § 600.345(a)(2)).

An applicant is required to attest to their household's projected annual income. (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security in order to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant in order to resolve the inconsistency (45 CFR § 155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any updates in eligibility to the Essential Plan effective the first day of the following month for changes received by NYSOH from the first to the fifteenth of any month (45 CFR § 155.420(b)(1)(i); *see also* 42 CFR § 600.320(c)). For updates received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR § 155.420(b)(1)(ii); *see also* 42 CFR § 600.320(c)).

Legal Analysis

The first issue under review is whether NYSOH properly determined that your eligibility for the Essential Plan ended effective August 31, 2017.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to his or her household's projected annual income. For individuals seeking enrollment in the Essential Plan, NYSOH

must request income data from federal data sources in order to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

In the eligibility determination issued on May 9, 2017, you were advised that you were eligible for the Essential Plan for a limited time, and that you needed to confirm your household's income before August 6, 2017.

You testified that you received the May 9, 2017 notice, and were aware of the need to provide income documentation to confirm your eligibility by August 6, 2017.

You testified that you attempted to fax income documentation to NYSOH on or about May 8, 2017, the same day as your updated application. You explained that you received a fax confirmation page but that you are no longer in possession of that confirmation page.

If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine an individual's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation.

No other income documentation was received by NYSOH until a scanned date of August 31, 2017.

Accordingly, your eligibility for the Essential Plan terminated as of August 31, 2017, because you did not submit documentation and did not adequately demonstrate that you could not provide documentation to confirm your income.

Therefore, the August 13, 2017, eligibility determination notice is AFFIRMED.

The second issue is whether NYSOH properly determined that your eligibility for and enrollment in the Essential Plan was effective October 1, 2017.

You updated your NYSOH application on August 25, 2017. That day you selected an Essential Plan for enrollment.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is

selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

Since on August 25, 2017, you selected an Essential Plan, your enrollment would properly take effect on the first day of the second month following August; that is, on October 1, 2017.

Therefore, the August 26, 2017, eligibility determination notice, and the August 26, 2017, enrollment confirmation notice stating that your enrollment in the Essential Plan was effective October 1, 2017, is correct they must be AFFIRMED.

Decision

The August 13, 2017, eligibility determination notice is AFFIRMED.

The August 26, 2017, notice of eligibility determination is AFFIRMED.

The August 26, 2017, notice of enrollment is AFFIRMED.

How this Decision Affects Your Eligibility

NYSOH properly found you not eligible to enroll in the Essential Plan effective August 31, 2017, because you did not provide documentation of your household's income.

NYSOH properly found that your reenrollment in the Essential Plan was effective October 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
