NOTICE OF DISMISSAL

On July 18, 2017, NY State of Health (NYSOH) issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month for a limited time, effective September 1, 2017. You requested an appeal insofar as the amount of financial assistance you were determined eligible to receive.

On October 16, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 7, 2017, at 3:00 pm.

On November 7, 2017, a Hearing Officer from the NYSOH Appeals Unit contacted you four times, with the assistance of Spanish interpreters, to conduct your scheduled hearing. Your hearing was unable to be conducted because you were inaudible, and the interpreter was unable to understand what you were stating. During the fourth attempt, the Hearing Officer adjourned your hearing until November 8, 2017, at 9:00 am. You agreed to the adjournment and waived formal notice of the telephone hearing.

On November 8, 2017, a Hearing Officer from the NYSOH Appeals Unit contacted, with the assistance of a Spanish interpreter, to conduct your scheduled hearing. You answered and identified yourself for the record; however, you were disconnected from the telephone call when the Hearing Officer was explaining the procedural process.

You were given notice of the time and date of the formal hearing in writing. NYSOH Appeals Unit made multiple attempts to contact you to conduct your telephone hearing; however, the hearing could not be completed.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
