NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On August 2, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your spouse remained eligible for Medicaid, effective August 1, 2017. You appealed that determination insofar as your spouse appeared to have been granted only presumptive Medicaid eligibility benefits during the month of August 2017, and you were seeking full Medicaid benefits for her coverage during that month.

On or about September 19, 2017, NYSOH took independent action to revise your spouse's Medicaid coverage during August 2017 to reflect that she was eligible for full Medicaid benefits.

On December 11, 2017, a Hearing Officer from the Appeals Unit of NYSOH called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your spouse's coverage had been corrected to reflect that she was eligible for full Medicaid benefits during the month of August 2017, and that you would be resubmitting her claims accordingly.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NYSOH will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
