NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On August 25, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your children were eligible for and enrolled in Child Health Plus, effective October 1, 2017. You appealed this determination.

On October 6, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 16, 2017, at 2:00 PM.

A Hearing Officer called you at 1:00 pm on November 16, 2017. You answered the phone and refused to be sworn in. You stated you wanted additional time to contact NYSOH to obtain additional information regarding your family's eligibility and enrollment so you could decide whether to proceed with your hearing or withdraw your hearing request. The Hearing Officer agreed to accommodate you and adjourned the hearing to Friday, December 1, 2017 at 10:00 am. The Hearing Officer stated that she would call you on December 1, 2017 at 10:00 am, that she would call you three times, and if you did not answer your hearing would be dismissed. You stated that you understood.

On December 1, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 10:01 am, 10:15 am, and 10:30 am, but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
