NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On September 13, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to enroll in the Essential Plan, effective October 1, 2017. You appealed this determination.

On October 19, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 13, 2017, at 2:00 p.m..

On November 13, 2017, a Hearing Officer called you. During this call, you requested that the telephone hearing be adjourned to a later date, as you were busy at work. The Hearing Officer granted your request for an adjourned hearing; which was scheduled for November 20, 2017 at 1:00 p.m..

On November 20, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 1:00 p.m., 1:15 p.m., and 1:30 p.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
