NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On July 1, 2017, NY State of Health (NYSOH) issued an enrollment notice stating that your qualified health plan (QHP) coverage would begin effective August 1, 2017.

On or about July 3, 2017, you requested that your QHP coverage start date begin effective July 1, 2017.

On July 24, 2017, NYSOH contacted you to inform you that your request for a QHP coverage start date of July 1, 2017 had been approved.

On September 12, 2017, you contacted NYSOH to request an appeal to reverse the backdating of your QHP coverage start date.

On November 20, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your NYSOH enrollment details reflect that you were enrolled in your QHP between July 1, 2017 and August 31, 2017, and your QHP insurance carrier was not seeking any additional premium amounts from you.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
