Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child's enrollment in her Medicaid Managed Care plan was effective October 1, 2017?

Procedural History

On June 9, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid, effective July 1, 2017. This notice stated that the type of Medicaid coverage you are eligible for does not require or allow you to enroll in a health plan because you have other full benefit health insurance.

On August 25, 2017, you updated your application for financial assistance to include your newborn child.

On August 26, 2017, NYSOH issued a notice of eligibility determination, based on your August 25, 2017 application, stating that your child was eligible for Medicaid, effective August 1, 2017.

Also on August 26, 2017, NYSOH issued a notice of enrollment in the plan you selected on August 25, 2017, stating that your child was enrolled in a Medicaid Managed Care plan, and that her coverage would start on October 1, 2017.

On September 14, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's enrollment in her Medicaid Managed Care plan, insofar as it did not begin as of her date of birth [REDACTED]

On November 2, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that your child was born on [REDACTED].
- 2) You testified, and your NYSOH account confirms, that you updated your NYSOH account to include your child on August 25, 2017.
- 3) The record reflects, that you selected your child's Medicaid Managed Care Plan on August 25, 2017, and that her enrollment was effective on October 1, 2017.
- 4) You testified that you had attempted to select a plan for your newborn before her birth so that she would have coverage.
- 5) You testified that you had third party health insurance through your school which ended on August 20, 2017.
- 6) You testified that you had straight Medicaid through NYSOH until September 1, 2017 at which time your Medicaid Managed Care plan started.
- 7) According to your NYSOH account, NYSOH voluntarily backdated your Medicaid Managed Care plan coverage to September 1, 2017.
- 8) You testified that you want your child's Medicaid Managed Care plan to begin on her date of birth [REDACTED], because you have medical bills that were not covered by Fee-For Service Medicaid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid for Newborns

Medicaid coverage must be provided to a child born to a woman who has been determined eligible and is receiving Medicaid on the date of the child's birth (42 CFR § 435.117(a), N.Y. Soc. Serv. Law § 366-g(3)). Additionally, Medicaid Managed Care plans are contractually obligated to provide coverage to eligible newborns based on the transaction date of the enrollment of the newborn (Medicaid Managed Care Model Contract (Appendix H-6 effective 3/1/2014 – 2/28/2019)).

Legal Analysis

The issue is whether NYSOH properly determined that your child's enrollment in her Medicaid Managed Care plan was effective October 1, 2017.

You testified, and the record reflects, that you updated your application to include your newborn child on August 25, 2017 and enrolled your child into a Medicaid Managed Care plan that day.

In New York State, Medicaid coverage must be provided to a child born to a woman who has been determined eligible and is receiving Medicaid on the date of the child's birth. The record reflects that on the date of your child's birth, you were eligible for Medicaid, but not enrolled into a Medicaid Managed Care plan because you had third party health insurance until August 20, 2017 that prevented you from enrolling into a Medicaid Managed Care plan sooner. Therefore, your child was not mandated to receive coverage through a Medicaid Managed Care plan as of her date of birth.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On August 25, 2017, you selected a Medicaid Managed Care plan for your child, so it properly took effect on the first day of the second month following after August 2017; that is, on October 1, 2017.

Therefore, the August 26, 2017 enrollment confirmation notice stating that your child's enrollment in her Medicaid Managed Care plan was effective October 1, 2017, was correct and must be AFFIRMED.

Decision

The August 26, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility.

The effective date of your child's Medicaid Managed Care plan is October 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
