Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly terminate your child from her Child Health Plus plan for non-payment of premium as of July 31, 2017?

Did the NYSOH properly determine that your child's enrollment in her Child Health Plus plan was effective October 1, 2017?

Procedural History

On February 3, 2017, NYSOH issued a renewal notice, stating that your child remained eligible for Child Health Plus, effective April 1, 2017.

On February 17, 2017, NYSOH issued an enrollment confirmation notice, stating that your child was enrolled in Child Health Plus, effective April 1, 2017.

On August 5, 2017, NYSOH issued a disenrollment notice, stating that your child's coverage would end on July 31, 2017, because you did not pay your insurance bill by the payment deadline.

On August 22, 2017, NYSOH issued an enrollment confirmation notice, stating that your child was enrolled in a Child Health Plus plan, effective October 1, 2017.

On September 18, 2017, you spoke to NYSOH's Account Review Unit and filed an appeal, insofar as your child did not have coverage for September 2017.

On December 1, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open up to December 15, 2017, to allow you to submit supporting documents.

Also on December 1, 2017, NYSOH received the documentation and it was incorporated into the record as appellant's Exhibit #1. The record was closed that day.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) Your child was enrolled in a Child Health Plus plan, effective April 1, 2017.
- 2) The record reflects that your child was disenrolled from her Child Health Plus plan as of July 31, 2017. The August 5, 2017 disenrollment notice states that your child was disenrolled because you did not pay your insurance bill by the payment deadline.
- 3) You testified that you routinely paid the premiums to your child's Child Health Plus plan for multiple months at a time, and that you mailed a money order on August 2, 2017 to pay the premium.
- 4) You testified that you were not required to pay a premium for the prior year, and that you believe you missed three months of premium payments this year.
- 5) You testified that you were not aware that your child had been disenrolled from her plan until you spoke with a representative on August 2, 2017, who told you that a termination date was set. The representative told you that she would note the account that you had mailed a money order.
- 6) The record reflects, that you reenrolled your child into a Child Health Plus plan on August 21, 2017.
- 7) You testified, and the record reflects, that your child was without health insurance for August 2017 and September 2017.
- 8) You testified that you are seeking Child Health Plus coverage for your child for September 2017, because you have outstanding bills for medical services rendered that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (4) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly terminated your child’s Child Health Plus plan for non-payment of premium as of July 31, 2017.

On February 17, 2017, your child's enrollment in a Child Health Plus plan was confirmed, with an effective date of April 1, 2017.

You testified that you routinely paid your child's Child Health Plus premiums for multiple months at a time, and that you mailed a money order on August 2, 2017 to pay the premium. You testified that you were not required to pay a premium for the prior year, and that you believe you missed three months of premium payments this year. On August 5, 2017, NYSOH issued a notice stating that your child was disenrolled from her Child Health Plus plan for non-payment of the premium, as of July 31, 2017.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) a failure to provide timely notice of an eligibility determination, and (4) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether your child was properly terminated from her Child Health Plus plan for non-payment of premiums. Therefore, your appeal of the August 5, 2017 disenrollment notice is **DISMISSED** as a non-appealable issue.

The second issue is whether NYSOH properly determined that your child's enrollment in her Child Health Plus plan was effective October 1, 2017.

The record reflects that you contacted NYSOH on August 21, 2017 and enrolled your child into a Child Health Plus plan.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you reenrolled your child into a plan on August 21, 2017, that plan would properly begin on the first day of the second following month after August, that is on October 1, 2017.

Therefore, the August 22, 2017 enrollment confirmation notice stating that your child's enrollment in her Child Health Plus plan was effective October 1, 2017, is correct and must be **AFFIRMED**.

Decision

Your appeal of the August 5, 2017 disenrollment notice is **DISMISSED** as a non-appealable issue.

The August 22, 2017 enrollment confirmation notice is **AFFIRMED**.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility.

The effective date of your child's Child Health Plus plan is October 1, 2017.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
