## NOTICE OF DISMISSAL – WITHDRAWAL

On September 13, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination stating that you were eligible to receive up to \$175.00 per month in advance payments of the premium tax credit, and eligible for cost-sharing reductions if you enrolled in a silver level qualified health plan, both effective October 1, 2017. The notice also stated that your spouse was eligible to purchase a qualified health plan at full cost.

On September 18, 2017, you filed an appeal of this eligibility determination, because you wanted you and your spouse to be eligible for Medicaid.

On November 14, 2017, you appeared at a telephone hearing before a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing, and was also kept open at the end of the hearing to allow you time to submit supporting documentation, which you did.

However, in the interim, NYSOH also reviewed the supporting documentation that you submitted after your hearing, and redetermined your household's eligibility for financial assistance. On November 29, 2017, NYSOH issued a new notice of eligibility determination stating that you and your spouse were eligible for Medicaid, effective November 1, 2017, and your children were eligible for Medicaid, effective December 1, 2017. Additionally, on December 1, 2017, NYSOH issued a notice stating that you were also eligible to receive Medicaid for the period from October 1, 2017 to October 31, 2017.

Based on this information during a phone call on December 8, 2017, you confirmed that your complaint has been resolved to your satisfaction, and that you wished to withdrawal your appeal. The Appeals Unit of NY State of Health will therefore not be issuing a substantive decision on your appeal.

However, should you change your mind, and decide that you would like NYSOH to issue a decision on your appeal, please contact NYSOH within 30 days of the date of this letter to let them know, and the Appeals Unit will issue a decision based on the record.

### **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NYSOH will not be reviewing this matter at this time.

### **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days of the date on this notice.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
