NOTICE OF DISMISSAL

Dear [REDACTED],

On September 22, 2017, you contacted NY State of Health (NYSOH) to re-enroll yourself and your child in a qualified health plan for 2017, but were denied your request to enroll in coverage outside of the 2017 open enrollment period. You appealed this denial.

On October 20, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 14, 2017 at 2:00 PM.

A Hearing Officer called you at 2:00 PM and then at 2:15 PM on November 14, 2017. Although you answered the call at 2:15 PM, after you were sworn in and were discussing whether you would proceed with the hearing, the call dropped. The Hearing Officer attempted to call you again at the same number, but there was no answer, and the call went to voicemail. No message was left, as your voicemail box was full.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
