NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On September 30, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to enroll in the Essential Plan and your child was eligible to enroll in Child Health Plus, effective November 1, 2017. You appealed this determination.

On October 20, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 14, 2017, at 11:00 a.m.

On November 14, 2017, a Hearing Officer contacted you and you requested an adjournment because you were at work and could not have a hearing at that time. The Hearing Officer agreed to adjourn your hearing until the next day, November 15, 2017, at 11:00 a.m.

On November 15, 2017, the Hearing Officer contacted you at 11:01 a.m. and went on the record. Through sworn testimony, you identified yourself and agreed to waive formal written notice of the adjourned hearing. During the procedural process of entering evidence into the record, the call was dropped on your end. The Hearing Officer then placed three calls to the telephone number that you provided to NYSOH and at you were reached the first time, at 11:07 a.m., 11:10 a.m., and 11:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
