## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Affinity Medicaid Managed Care plan was effective November 1, 2017?

## Procedural History

On April 11, 2017, NYSOH issued a notice of eligibility determination, based on your April 10, 2017 application, stating that you would remain eligible for Medicaid, effective May 1, 2017.

Also on April 11, 2017, NYSOH issued an enrollment confirmation notice based on your plan selection on May 1, 2017, stating that you were enrolled in your Empire BlueCross BlueShield Medicaid Managed Care plan, and that your coverage would start on May 1, 2017.

On September 20, 2017, you contacted NYSOH and requested to enroll into an Affinity Medicaid Managed Care plan.

On September 21, 2017, NYSOH issued an enrollment confirmation notice based on your plan selection on September 20, 2017, stating that you were enrolled in your Affinity Medicaid Managed Care plan, and that your coverage would start on November 1, 2017.

Also on September 21, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Affinity Medicaid Managed Care plan, insofar as it did not begin September 1, 2017.

On September 22, 2017, NYSOH issued a disenrollment notice stating that your enrollment with your Empire BlueCross BlueShield Medicaid Managed Care plan would end on October 31, 2017.

On November 28, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you had previously enrolled in your Empire BlueCross BlueShield Medicaid Managed Care plan because you believed the hospital where you receive medical treatment accepted this plan. You explained that the hospital's website indicated they accept Empire BlueCross BlueShield, but you were later informed that they did not accept the specific Empire BlueCross BlueShield plan you had.
- 2) You testified that you believe you contacted NYSOH to change your Medicaid Managed Care plan from Empire BlueCross BlueShield to Affinity at the beginning of September 2017.
- 3) Your NYSOH account reflects that you first contacted NYSOH to change plans from your Empire BlueCross BlueShield plan to an Affinity plan on September 20, 2017, and that your enrollment was effective on November 1, 2017.
- 4) You testified that you want your Affinity Medicaid Managed Care plan to begin on September 1, 2017 because you received medical treatment in September 2017 at a hospital that does not accept the Empire BlueCross BlueShield Medicaid Managed Care plan.
- 5) You testified that you may have been seen in a [REDACTED] in September 2017 or October 2017, for which the Empire BlueCross BlueShield Medicaid Managed Care plan may have paid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your enrollment in your Affinity Medicaid Managed Care plan was effective November 1, 2017.

You testified that you contacted NYSOH at the beginning of September 2017 to change plans from your Empire BlueCross BlueShield plan to an Affinity plan on September 20, 2017, and that your enrollment was effective on November 1, 2017.

However, the credible evidence of record indicates that you first contacted NYSOH on September 20, 2017 to change plans from your Empire BlueCross BlueShield Medicaid Managed Care plan to an Affinity Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On September 20, 2017, you selected an Affinity Medicaid Managed Care plan, so it properly took effect on the first day of the second month following after September 2017; that is, on November 1, 2017.

Therefore, the September 21, 2017 enrollment confirmation notice stating that your enrollment in your Affinity Medicaid Managed Care plan would be effective November 1, 2017, was correct and must be AFFIRMED.

## **Decision**

The September 21, 2017 eligibility determination notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your Affinity Medicaid Managed Care plan is November 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
