Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your children's enrollment in their Child Health Plus plan was effective November 1, 2017?

Procedural History

On August 10, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your August 9, 2017 application, stating that your children were eligible to enroll in Child Health Plus with a \$45.00 monthly premium each, effective September 1, 2017. This notice advised you that you needed to pick a plan for your children and that you would receive written confirmation from NYSOH once you had selected a plan.

On September 21, 2017, you selected a health plan for your two children with a start date of November 1, 2017.

On September 21, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin September 1, 2017.

Also on September 22, 2017, NYSOH issued a notice of enrollment, based on your plan selection on September 21, 2017, stating your children were enrolled in a Child Health Plus plan, and that this enrollment in the plan would start November 1, 2017.

On December 7, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your children's health plan start date, requesting a start of September 1, 2017.
- 2) You submitted an application to NYSOH for financial assistance on August 9, 2017.
- 3) You explained you were not aware that you had to select a health plan when you were applying online on August 9, 2017. You thought you completed the renewal.
- 4) You testified, and the record reflects, that you enrolled your children into a Child Health Plus plan on September 21, 2017.
- 5) You testified your children's prior health coverage was directly through their health plan and not through NYSOH.
- 6) You testified you first realized your children's health plan had lapsed when you received a letter from their health plan in September 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or

through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your children’s enrollment in their Child Health Plus plan was effective November 1, 2017.

You testified that you completed your children’s application online on August 9, 2017. You believed that you had completed your application and was not aware you had to select a health plan for your children.

After receiving a letter from your health plan that your children’s health plan had ended, you contacted NYSOH on September 21, 2017 and enrolled your children into a Child Health Plus plan that day.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected a plan for your children on September 21, 2017, there plan would properly begin on the first day of the second following month after September 2017; that is on November 1, 2017.

Therefore, the September 22, 2017, enrollment confirmation notice stating that your child’s enrollment in their Child Health Plus plan was effective November 1, 2017, is correct and must be AFFIRMED.

Decision

The September 22, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

The effective date of your children's Child Health Plus plan is November 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

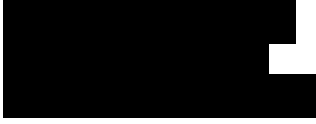
The September 22, 2017 enrollment confirmation notice is AFFIRMED.
