NOTICE OF DISMISSAL

Dear [REDACTED],

On September 22, 2017, NY State of Health (NYSOH) issued an enrollment notice confirming that your son's Child Health Plus (CHP) plan coverage would begin effective November 1, 2017. You appealed insofar as you were seeking his CHP plan coverage to begin no later than October 1, 2017.

On October 25, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 16, 2017, at 11:00 a.m.

A Hearing Officer called you at 11:05 a.m. on November 16, 2017. Although you answered the call, you stated that you no longer wanted to proceed with the appeal since October 2017 had already passed and a backdate of his coverage to October 1, 2017 would be of no use to him. The Hearing Officer requested to go on the record and place you under oath to obtain a formal withdrawal. You stated that you did not have the time, and to just dismiss the appeal.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
