Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid assistance from July 1, 2017 through July 31, 2017?

Procedural History

On August 22, 2017, you submitted two applications for financial assistance with health insurance and indicated in the first that you were seeking help paying for medical bills for July 2017.

On September 1, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid. This eligibility was effective as of August 1, 2017. Also on September 1, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid in the month of June 2017.

On September 28, 2017, you spoke to NYSOH's Account Review Unit and appealed, insofar as it NYSOH verbally denied your request for retroactive Medicaid for the month of July 2017.

On November 16, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open through December 1, 2017, to allow you to submit supporting documents.

On November 17, 2017, NYSOH received a three-page fax submitted on your behalf. The record is now closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid from July 1, 2017 through July 31, 2017.
- 2) You testified that you expect to file your 2017 federal income tax return as single, and claim no dependents.
- 3) You submitted two applications for financial assistance on August 22, 2017.
- 4) The first application submitted on August 22, 2017, states that for the month of July 2017, your income was \$1,571.75.
- 5) NYSOH did not issue an eligibility determination regarding your eligibility for Medicaid in the month of July 2017.
- 6) You testified that, in the month of July 2017, you were paid biweekly and worked about 40 hours per week for \$11.30 an hour.
- 7) After the hearing, you faxed two biweekly paystubs to NYSOH dated July 13, 2017 and July 27, 2017 for gross pay amounts of \$903.06 and \$901.81. These documents are collectively marked and entered into the record as "Appellant's Exhibit One."
- 8) You testified that you have a lot of medical bills from the month of July 2017 that you need covered.
- 9) According to the notes in [REDACTED], you called NYSOH on September 28, 2017 to ask about your eligibility for retroactive coverage for the month of July 2017. Notes entered by a NYSOH agent on that day state, "Advised consumer that she is not eligible for the month of 7/2017."

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Federal Register 8831).

Retroactive Medicaid

The Department of Health must provide Medicaid assistance retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he or she had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid for July 1, 2017 through July 31, 2017.

You are in a one-person household; you file your taxes with a tax filing status of single and claim no dependents on your tax return.

You submitted two applications for financial assistance on August 22, 2017 and, in the first application, requested help paying for medical bills for July 2017.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether that initial application resulted in Medicaid going forward. Instead, an individual who has filed an initial application for Medicaid through NYSOH has

the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in July 2017, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during July 2017.

After the hearing, you uploaded two paystubs dated July 13, 2017 and July 27, 2017 for gross pay amounts of \$903.06 and \$901.81. Therefore, the record indicates that in the month of July 2017, you had a monthly household income of \$1,804.87.

Since your income of \$1,804.87 was more than the \$1,387.00 monthly Medicaid limit for July 2017, NYSOH properly determined that you were not eligible for Medicaid coverage during that month and NYSOH's verbal denial of your request for Medicaid coverage in July 2017 is AFFIRMED.

Decision

NYSOH's verbal determination that you were not eligible for Medicaid in the month of July 2017 was correct and is AFFIRMED.

Effective Date of this Decision: November 29, 2017

How this Decision Affects Your Eligibility

You were not eligible for Medicaid in the month of July 2017, based on your income in that month.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

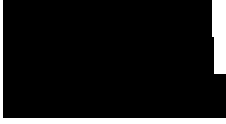
NYSOH's verbal determination that you were not eligible for Medicaid in the month of July 2017 was correct and is AFFIRMED.
