## NOTICE OF DISMISSAL – FAILURE TO APPEAR

On September 30, 2017, NY State of Health (NYSOH) issued a notice of enrollment confirming your child was enrolled in a Child Health Plus plan effective November 1, 2017. You appealed the effective date of that coverage.

On November 22, 2017, NYSOH issued a Notice of Hearing to advise you the hearing you requested was scheduled for December 18, 2017, at 1:00 p.m.

On December 18, 2017, a Hearing Officer called you at 1:00 p.m. Although you answered the call, you indicated you were too ill to proceed with the hearing as scheduled. The Hearing Officer agreed to adjourn the hearing to December 28, 2017 at 3:00 p.m. You were advised that the hearing would be dismissed if you were not available at that date and time.

On December 28, 2017, the Hearing Officer placed three calls to the telephone number you provided to NYSOH, at 3:03 p.m., 3:15 p.m., and 3:30 p.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
