## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child's eligibility for and enrollment in Child Health Plus terminated effective September 30, 2017?

## Procedural History

On June 21, 2017, you updated your NYSOH account and applied for health insurance for your oldest child (herein after referred to as child) on his behalf.

On June 22, 2017, NYSOH issued an eligibility determination notice stating in part, that your child was conditionally eligible to enroll in Child Health Plus with a \$9.00 per month premium effective August 1, 2017. The notice requested that you provide documentation confirming his citizenship status before September 19, 2017.

Also on June 22, 2017, NYSOH issued a notice confirming your child's enrollment in a Child Health Plus plan, effective August 1, 2017.

On September 25, 2017, NYSOH issued an eligibility determination notice stating that your child was no longer eligible for health insurance through NYSOH. The notice stated that this was because you did not provide the proof of his citizenship status within the required timeframe.

Also on September 25, 2017, NYSOH issued a disenrollment notice stating that your child's coverage in his Child Health Plus plan would end effective September 30, 2017 because he was no longer eligible to enroll in health insurance through NYSOH.

On October 2, 2017, your child's U.S. passport was added to your NYSOH account and was verified as proof of citizenship that day.

On October 3, 2017, NYSOH issued an eligibility determination notice, based on the October 2, 2017 application, stating in part, that your child was eligible to enroll in Child Health Plus with a \$9.00 per month premium, effective November 1, 2017.

Also on October 3, 2017, you spoke to NYSOH's Account Review Unit and appealed your child's disenrollment from his Child Health Plus plan in the month of October 2017.

On October 4, 2017, NYSOH issued an enrollment confirmation notice, based on your October 3, 2017 plan selection, stating that your child was enrolled in a Child Health Plus plan, with a plan enrollment start date of November 1, 2017.

On December 5, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are only appealing your child's disenrollment from his Child Health Plus plan for the month of October 2017.
- 2) The record indicates that you submitted an application for health insurance for your oldest child on June 21, 2017 to NYSOH. The application that was submitted that day indicates that he was a U.S. citizen.
- 3) The June 22, 2017, eligibility determination stated that your child's eligibility was conditional and that you needed to submit proof of his citizenship status by September 19, 2017.
- 4) According to your NYSOH account, no proof of your child's citizenship was submitted by September 19, 2017.

- 5) You testified that the September 25, 2017 eligibility determination was the first you knew that you needed to submit proof of your child's citizenship status.
- 6) According to your NYSOH account, your child's Child Health Plus plan terminated effective September 30, 2017.
- 7) According to your NYSOH account and your testimony, on October 2, 2017, you submitted a copy of your child's U.S. passport and it was verified on that date.
- 8) According to your NYSOH account and your testimony, you selected a Child Health Plus plan for your child on October 3, 2017 with a plan start date of November 1, 2017.
- 9) You testified that your child was hospitalized on [REDACTED] and that he needed to see a specialist for his condition two weeks later. The bill for seeing that specialist in October 2017 is unpaid because your child did not have health insurance that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Child Health Plus

A child who meets the eligibility requirements for Child Health Plus may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (New York Public Health Law (NY PHL) § 2511(2)(a)(iii)).

To be eligible for Child Health Plus, the child:

- Must be under 19 years of age;
- Must be a New York State Resident;
- Must not have other health insurance coverage; and
- Must not be eligible for, or enrolled in, Medicaid

(NY PHL § 2511(2)(a)-(e)).

As a condition of eligibility for Child Health Plus, an individual, including children, must furnish their Social Security Number and evidence of their citizenship or status as a qualified immigrant or PRUCOL alien to NY State of Health for

verification purposes (42 CFR § 435.910(a) and (b)(3); 42 CFR § 457.340(b); 18 NYCRR § 360-3.2(j)(2) and (3); see *generally* 18 NYCRR § 360-3.2(j)).

NYSOH must require an applicant who has a Social Security Number to provide the number but does not require an applicant's Social Security Number as a condition of enrollment for Child Health Plus if the applicant is not eligible to receive one or his or her number is not yet available (42 CFR § 457.340(b), 42 CFR § 435.910(h)(1); Model State Children's Health Insurance Program Plan, Section 4.1.9).

If an applicant attests to citizenship, status as a national, or lawful presence, and NYSOH is unable to verify such attestation, NY State of Health must then provide the applicant with 90 days to provide satisfactory documentary evidence. Notice is considered received 5 days after the date on the notice, unless the applicant demonstrates that he or she did not receive the notice within the 5-day period (45 CFR § 155.315(c)(3), (f)(2)(i)).

If NYSOH remains unable to verify the citizenship attestation after the 90-day period ends, it must determine the applicant's eligibility based on the information available (45 CFR § 155.315(f)(5)).

NYSOH is required to provide proper written notice to an applicant of any decision effecting an enrollee's Child Health Plus eligibility (42 CFR § 457.340(e)). When Child Health Plus coverage is denied, suspended or terminated NYSOH must provide sufficient notice to enable the child's parent or caretaker relative to take appropriate actions to allow Child Health Plus coverage to continue without interruption (42 CFR § 457.340(e)(2); 42 CFR § 457.1130(a)(3)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that your child's eligibility for and enrollment in Child Health Plus terminated effective September 30, 2017.

NYSOH is required to determine whether individuals are eligible to enroll in coverage through NYSOH, and must confirm, among other things, their Social Security number and citizenship status.

If NYSOH cannot verify an individual's citizenship status or Social Security number, it must provide the individual with notice of the inconsistency. NYSOH must then provide the individual with a period of 90 days from the date notice is received to resolve the inconsistency.

The record indicates that you submitted an application for health insurance for your oldest child on June 21, 2017. The application that was submitted that day indicates that he was a U.S Citizen. The June 22, 2017, eligibility determination stated that your child's eligibility was only conditional and that you needed to submit proof of his citizenship status by September 19, 2017.

The record indicates that NYSOH did not have proof of your child's citizenship before the September 19, 2017 deadline.

On September 25, 2017, NYSOH issued a disenrollment notice stating that your child's coverage in his Child Health Plus plan would end effective September 30, 2017 because he was no longer eligible to enroll in health insurance through NYSOH. According to the eligibility determination issued on that day, this was because NYSOH did not receive documentation of his citizenship status.

When NYSOH denies, terminates, or suspends a child's Child Health Plus coverage, they are required to provide sufficient notice so that a child's parent is able to take action to prevent a gap in coverage for the child. Notice is considered received five days after the date on the notice. In this case, the notice formally disenrolling your child from his Child Health Plus plan was dated September 25, 2017. Therefore, the notice terminating your child's enrollment would be considered received as of September 30, 2017.

When changes are made to an individual's application after the 15th of any month, NYSOH must make the redetermination that results from a change effective the first day of the next following month. Since you would have received NYSOH's notice terminating your child's Child Health Plus eligibility after the 15<sup>th</sup> of the month, any changes you would have made to your account to prevent a gap in coverage would not have been effective until November 1, 2017.

Therefore, NYSOH failed to provide you with sufficient notice that would have allowed you to take action in order to prevent a gap in Child Health Plus coverage for your child for the month of October 2017 and the September 25, 2017 eligibility determination and disenrollment notices are **RESCINDED**.

## **Decision**

The September 25, 2017 eligibility determination and disenrollment notices are **RESCINDED**.

Your case is **RETURNED** to NYSOH to reinstate your child into his Child Health Plus plan for the month of October 2017.

## **How this Decision Affects Your Eligibility**

Your child should not have been terminated from his Child Health Plus plan in October 2017 for failure to submit proof of his citizenship status.

Your case is being sent back to NYSOH to reinstate your child into his Child Health Plus for the month of October 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
