## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective November 1, 2017?

## Procedural History

On August 29, 2017, you submitted an application for financial assistance.

On September 1, 2017, NYSOH issued a notice of eligibility determination, based on your August 29, 2017 application, stating that you were eligible for Medicaid, effective August 1, 2017.

On September 14, 2017, NYSOH issued a notice of enrollment in the plan you selected on September 13, 2017, stating that you were enrolled in a Medicaid Managed Care plan (Empire), and that your coverage would start on October 1, 2017.

On September 19, 2017, you selected a new Medicaid Managed Care plan (Healthfirst).

On September 23, 2017, NYSOH issued an enrollment confirmation notice stating that your Medicaid Managed Care plan (Healthfirst), would begin on November 1, 2017.

Also on September 23, NYSOH issued a disenrollment notice stating that your coverage in your Medicaid Managed Care plan (Empire) would be ending October 31, 2017.

On October 3, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan (Healthfirst), insofar as it did not begin October 1, 2017.

On December 12, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on August 29, 2017.
- 2) You were determined eligible for Medicaid, effective August 1, 2017.
- 3) You testified, and your account confirms, that you selected your Medicaid Managed Care Plan (Empire) on September 13, 2017, and that your enrollment was effective on October 1, 2017.
- 4) On September 19, 2017, you selected a new Medicaid Managed Care plan (Healthfirst).
- 5) On September 23, 2017, NYSOH issued an enrollment confirmation notice stating that your Medicaid Managed Care plan (Healthfirst) would begin November 1, 2017.
- 6) You testified that you were not aware that you had to select a qualified health plan on or before September 15, 2017 for your qualified health plan to begin on October 1, 2017.
- 7) You testified that you want your Medicaid Managed Care plan (Healthfirst) to begin on October 1, 2017 because you incurred a medical bill in October 2017 which was not covered by your previous Medicaid Managed Care plan (Empire).

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your enrollment in a Medicaid Managed Care plan (Healthfirst) was effective November 1, 2017.

You testified that you contacted NYSOH on September 19, 2017 and enrolled into a Medicaid Managed Care plan (Healthfirst).

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On September 19, 2017, you selected a Medicaid Managed Care plan (Healthfirst), so it properly took effect on the first day of the following month; that is, on November 1, 2017.

Therefore, the September 23, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan (Healthfirst) would be effective November 1, 2017, was correct and must be AFFIRMED.

## **Decision**

The September 23, 2017 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan (Healthfirst) is November 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
