## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your newborn's enrollment in his Medicaid Managed Care (MMC) plan was effective October 1, 2017?

## Procedural History

According to your NYSOH account, your child was systematically added to your account on August 21, 2017, and an application for financial assistance was submitted on his behalf.

On August 22, 2017, NYSOH issued an eligibility determination notice stating that your child was conditionally eligible for Medicaid, effective August 1, 2017. The notice stated that you must pick a health plan for your child, or a health plan will be chosen for him.

On September 1, 2017, NYSOH issued a plan enrollment notice confirming your child's enrollment in the MMC plan on August 31, 2017, and that his coverage would start on October 1, 2017. The notice stated that your child was enrolled in this plan because you did not select a health plan for him.

On October 3, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's enrollment in his MMC plan insofar as it did not begin the day your child was born.

On December 12, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, your child was born on [REDACTED]
- 2) According to your NYSOH account, your child was systemically added to your account on August 21, 2017, and an application for financial assistance was submitted on his behalf.
- 3) According to your NYSOH account, because you did not select an MMC plan for your child, an MMC plan was selected for him on August 31, 2017, and his enrollment was effective on October 1, 2017.
- 4) You testified that you want your child's MMC plan to begin on the day he was born because you have uncovered medical bills for him.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that your child's enrollment in his MMC plan was effective October 1, 2017.

According to your NYSOH account, your child was systemically added to your account on August 21, 2017, and an application for financial assistance was submitted on his behalf. Your child was determined eligible for Medicaid, effective August 1, 2017, the first day in his month of birth in which he was determined conditionally eligible for Medicaid. This is in accordance with Medicaid regulations and the first of the month rule noted above.

According to the August 22, 2017 eligibility determination notice, you were informed of your child's eligibility and that you needed to select a health plan for your child or one would be chosen for him. Because you did not select an MMC plan for your child, as informed, an MMC plan was selected for him on August 31, 2017, and his enrollment was effective on October 1, 2017, as stated in the September 1, 2017 plan enrollment notice.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

Since an MMC plan was selected for your child on August 31, 2017, it properly took effect on the first day of the second month following August 2017; that is, on October 1, 2017.

Therefore, the September 1, 2017 plan enrollment notice confirming that your child's enrollment in his MMC plan would be effective October 1, 2017, was correct and must be AFFIRMED.

## **Decision**

The September 1, 2017 plan enrollment notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your child's eligibility for Medicaid or enrollment in his MMC plan.

Your child had Medicaid Fee-For-Service, effective August 1, 2017.

The effective date of your child's MMC plan is October 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
