## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that your oldest child was eligible for the Essential Plan, effective November 1, 2017?

Did NY State of Health properly determine that your oldest child was not eligible for Medicaid?

## Procedural History

On September 12, 2017, you submitted an application on behalf of your oldest child.

On September 13, 2017, NY State of Health (NYSOH) issued an eligibility determination notice stating your oldest child was eligible to enroll in the Essential Plan for a cost of \$20.00 per month, effective October 1, 2017.

On September 28, 2017, you submitted an updated application for financial assistance for your oldest child.

On September 29, 2017, NYSOH issued a plan enrollment notice confirming your oldest child's enrollment in an Essential Plan, effective November 1, 2017.

On October 1, 2017, NYSOH issued an eligibility determination notice stating that your oldest child was eligible to enroll in the Essential Plan for a cost of \$20.00 per month, effective November 1, 2017. The notice stated your oldest child was

not eligible for Medicaid because the household income you provided of \$32,240.00 was over the allowable income limit for that program.

On October 5, 2017, you spoke to NYSOH's Account Review Unit and appealed the October 1, 2017 eligibility determination notice relative to your oldest child's eligibility for financial assistance.

On December 18, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. During your hearing, you amended your appeal to include that you are not only appealing your child's eligibility for the Essential Plan and would like his eligibility redetermined for Medicaid. The record was developed during the hearing and held open to January 2, 2018, to allow you to submit supporting documents.

As of January 2, 2018, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of Head of Household. You will claim two dependents on that tax return.
- 2) You are seeking health insurance for your oldest child. You believe he should be eligible for Medicaid.
- 3) According to your NYSOH account, your oldest child was [REDACTED] at the time of your September 28, 2017 application.
- 4) The application that was submitted on September 28, 2017, listed an annual household income of \$32,240.00, consisting of \$620.00 per week you earn from your employer. You testified that this amount was correct.
- 5) You testified that you expect this amount to decrease beginning in November 2017, because you were working less hours.
- 6) You did not provide any income documents to prove your household income in September 2017, the month of your child's application, or to prove you had decreased earnings beginning in November 2017.
- 7) Your application states that you will not be taking any deductions on your 2017 tax return.

8) Your application states that you live in Monroe County, New York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$20,160.00 for a three-person household (81 Federal Register 4036.).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage. Therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

### Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for

Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

A child aged 19 or 20, whose primary residence is with their parents, is eligible for Medicaid if he or she meets the non-financial criteria and has a household modified adjusted gross income that falls at or below 155% of the federal poverty level (FPL) for the applicable family size (NY Social Services Law § 366(b)(7)); New York State Department of Social Services Administrative Directive 13 OHIP/ADM-03).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4).

On the date of your application, that was the 2017 FPL, which is \$20,240.00 for a three-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

In the case of an individual who expects to file a tax return and does not expect to be claimed by another taxpayer, the household consists of the taxpayer and all persons whom such individual expects to claim as a tax dependent (42 CFR § 435.603(f)(1)).

### Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term “modified adjusted gross income” means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income.

## **Legal Analysis**

The first issue under review is whether NYSOH properly determined that your oldest child was eligible for the Essential Plan, effective November 1, 2017.

The application that was submitted on September 28, 2017, listed an annual household income of \$32,240.00 and the eligibility determination relied upon that information.

Your oldest child is in a three-person household for purposes of this analysis. This is because you expect to file your 2017 income taxes as Head of Household and will claim two dependents on that tax return.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$20,160.00 for a three-person household. Since an annual household income of \$32,240.00 is 159.92% of the 2016 FPL, NYSOH properly found your oldest child to be eligible for the Essential Plan.

The second issue under review is whether NYSOH properly determined that your oldest child was ineligible for Medicaid.

The record reflects that your oldest child was [REDACTED] on the date of your September 28, 2017 application.

Medicaid can be provided through NYSOH to children 19 and 20 years old who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 155% of the FPL for the applicable family size. There is nothing in your NYSOH to suggest that your oldest child did not meet the non-financial requirements. Therefore, the analysis turns to the financial requirements.

On the date of your application, the relevant FPL was \$20,420.00 for a three-person household. Since a household income of \$32,240.00 is 157.88% of the 2017 FPL, NYSOH properly found your oldest to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

The record was held open for you to provide supporting documentation of your monthly income in September 2017; the month of your application for your oldest child and for proof of income as of November 2017. Since NYSOH Appeals Unit did not receive the requested documentation as of the close of the record on January 2, 2018, an analysis of your child's eligibility for Medicaid on a monthly basis cannot be made.

Since the October 1, 2017 eligibility determination properly stated that, based on the information you provided, your oldest child was eligible for the Essential Plan, and ineligible for Medicaid, it is correct and is AFFIRMED.

## **Decision**

The October 1, 2017 eligibility determination notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

Your oldest child remains eligible for the Essential Plan.

Your oldest child is ineligible for Medicaid.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the
