NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On September 29, 2017, NY State of Health (NYSOH) issued a notice of enrollment stating your oldest child's Essential Plan enrollment was effective November 1, 2017. The notice further stated your youngest child's enrollment in his Child Health Plus plan was effective November 1, 2017. You appealed that notice.

On December 18, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal on the start date of your children's health plans. You amended your appeal to only include your oldest child's level of financial assistance requesting he be redetermined for Medicaid.

You therefore withdrew your appeal for this issue on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

A decision will be issued on your appeal of your oldest child's eligibility for Medicaid.

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
