## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did New York State of Health (NYSOH) properly determine that your youngest child's ([REDACTED]) enrollment in her Child Health Plus plan was effective May 1, 2017?

## Procedural History

On June 8, 2017, NYSOH received your application for health insurance.

On June 9, 2017, NYSOH issued an eligibility determination notice stating that your children were eligible to enroll in Child Health Plus, effective July 1, 2017.

On June 16, 2017, NYSOH issued an enrollment confirmation notice, stating that your children were enrolled in a Child Health Plus plan, effective July 1, 2017.

On October 5, 2017, NYSOH issued an enrollment confirmation notice, stating that your children were enrolled in a Child Health Plus plan, effective May 1, 2017.

On October 6, 2017, you spoke to NYSOH's Account Review Unit and filed an appeal insofar as your youngest child's enrollment [REDACTED] in her Child Health Plus plan began on May 1, 2017, and not July 1, 2017.

On December 7, 2017, your spouse appeared for a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your youngest child's enrollment start date.
- 2) You submitted an application to NYSOH for financial assistance on June 8, 2017.
- 3) You testified, and the record reflects, that you enrolled your children into a Child Health Plus plan on June 15, 2017.
- 4) You testified, and the record reflects that your youngest child had Medicaid through the local department of social services until June 30, 2017.
- 5) On June 15, 2017, you requested that your oldest child's Child Health Plus coverage be reinstated as of May 1, 2017 (Complaint [REDACTED]).
- 6) You testified that you need your youngest child's Child Health Plus plan to begin on July 1, 2017, because she had Medicaid coverage and you do not want to pay the Child Health Plus premiums.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Child Health Plus

Child Health Plus (CHP) is a sliding-scale-premium program for children who are in a household that is over income for regular Medicaid (see New York Public Health Law (NY PHL) § 2510 et seq. and 42 USC § 1397aa). Eligibility rules are set out in NY PHL § 2511(2), as well as in the NYS Department of Health 2008-2012 Contract and Plan Manual.

A child who meets the eligibility requirements for CHP may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (NY PHL § 2511(2)(a)(iii)). To

be eligible to enroll in CHP with subsidy payments, a child must not be “eligible for medical assistance”; that is, must not be eligible for Medicaid (NY PHL § 2511(2)(b)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your youngest child’s (██████████) enrollment in her Child Health Plus plan was effective May 1, 2017.

The record reflects that you enrolled your children into a Child Health Plus plan on June 15, 2017. As a result, your two children were enrolled in a Child Health Plus plan, effective July 1, 2017.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected a plan for your children on June 15, 2017, their plan would have properly begun on the first day of the next following month after June; that is on July 1, 2017.

However, on June 15, 2017, you contacted NYSOH and requested that your oldest child have coverage in his Child Health Plus plan, effective May 1, 2017. This request was subsequently granted.

On October 5, 2017, NYSOH issued an enrollment confirmation notice stating that both of your children were enrolled into a Child Health Plus plan effective May 1, 2017.

Since the record indicates that you had only requested your oldest child's Child Health Plus plan to begin May 1, 2017 and because your youngest child was eligible for Medicaid through their Local Department of Social Services in May and June 2017, NYSOH erred in making the start date of your youngest child's Child Health Plus plan May 1, 2017.

Therefore, the October 5, 2017 enrollment confirmation notice is MODIFIED in part, to state that your youngest child's enrollment in a Child Health Plus plan is effective July 1, 2017.

Your case is RETURNED to NYSOH to terminate your youngest child's [REDACTED] enrollment in her Child Health Plus plan for the months of May and June 2017 and to ensure that the start date of her plan is July 1, 2017.

## **Decision**

The October 5, 2017 enrollment confirmation notice is MODIFIED in part, to state that your youngest child's enrollment in a Child Health Plus plan is effective July 1, 2017.

Your case is RETURNED to NYSOH to terminate your youngest child's ([REDACTED]) enrollment in her Child Health Plus plan for the months of May and June 2017 and to ensure that the start date of her plan is July 1, 2017.

## **How this Decision Affects Your Eligibility**

The effective date of your youngest child's Child Health Plus plan is July 1, 2017.

Your case is being sent back to NYSOH to correct her enrollment start date to July 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
