Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were eligible for Medicaid effective August 1, 2017?

Procedural History

On August 1, 2017, you submitted an application for financial assistance with health insurance and indicated that you were seeking help for paying for medical bills for the month of July 2017.

On August 2, 2017, NYSOH issued a notice stating the income information in your application did not match what NYSOH received from state and federal data sources. The notice directed you provide proof of your household income by August 16, 2017.

No income documentation was received by the deadline.

On August 29, 2017, NYSOH issued a notice stating that you were eligible to purchase a qualified health plan at full cost, effective October 1, 2017, and were not eligible for Medicaid because NYSOH did not receive the requested information to verify your income by the deadline.

On August 29, 2017, NYSOH received your income documentation in the form of a letter from your employer, which was uploaded to your NYSOH account.

On August 30, 2017 NYSOH issued a notice stating the income information in your application did not match what NYSOH received from state and federal data sources. The notice directed you provide proof of your household income by September 13, 2017.

On August 30, 2017, a NYSOH representative reviewed your income documentation and submitted an application on your behalf.

On August 31, 2017 NYSOH issued a notice based on your last application stating that you were eligible for Medicaid, effective August 1, 2017. The notice stated this was because your income of \$16,000.00 was at or below the income limit of \$16,643.00.

On September 1, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in a Medicaid Managed Care plan, effective October 1, 2017.

On October 10, 2017, you spoke to NYSOH's Account Review Unit and appealed the August 31, 2017 eligibility determination notice insofar as it determined you eligible for Medicaid for August 2017, and not July 2017.

On December 4, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open to December 19, 2017, to allow you to submit supporting documents.

As of December 19, 2017, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid from July 1, 2017 to July 31, 2017, to cover medical bills you incurred that month.
- 2) You testified that you expect to file your 2017 federal income tax return as single, and claim no dependents.
- 3) You submitted an application for financial assistance on August 1, 2017.
- 4) You provided income documentation in the form of a letter from your employer stating for the year of 2016 you earned \$15,510.00. The

letter was signed and dated August 23, 2017 (see Document [REDACTED]).

- 5) Your application submitted on August 1, 2017, states that for the month of July 2017, your income was \$1,666.67. You testified you believe this amount was correct.
- 6) You testified that your hours at your employment vary such that your income can vary, too.
- 7) You testified that you do not plan on taking any deductions on your tax return for 2017.
- 8) According to your NYSOH account, you reside in [REDACTED], NY.
- 9) At the close of business on December 19, 2017, the time at which the record was to close, NYSOH's Appeals Unit had not received your income documentation for the month of July 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4).

On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR §

435.915(b); Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13 ADM-03(III)(F)).

Medicaid Managed Care (MMC) plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H(6)(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; NY Social Services Law § 364-j(1)(c); 18 NYCRR § 360-10.3(h); Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13 ADM-03(III)(F)).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were eligible for Medicaid effective August 1, 2017.

You are in a one-person household for purposes of this analysis. This is because you file your taxes with a tax filing status of single and claim no dependents on your tax return.

You submitted an application for financial assistance on August 1, 2017 and requested help in paying for medical bills from July 1, 2017 through July 31, 2017. You testified this request was accurate.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services

that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in July 2017, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during July 2017.

You provide income documentation in the form of a letter from your employer stating your gross wages, which were for the year of 2016. After your telephone hearing, the Hearing Officer left the record until December 19, 2017, for you to provide income documentation showing your actual earnings for the month of July 2017. At the close of business on December 19, 2017, the deadline to submit documentation, NYSOH's Appeals Unit had not received your income documentation for the month of July 2017. Lacking such evidence, a determination your eligibility retroactively for Medicaid for the month of July 2017 cannot be made.

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month.

You first submitted an application for Medicaid on August 1, 2017 and on August 30, 2017 you were determined eligible for Medicaid, effective August 1, 2017. Therefore, the August 31, 2017 eligibility determination notice was proper and is AFFIRMED.

Decision

The August 31, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

A determination cannot be made on your eligibility retroactively for Medicaid for the month of July 2017, because you did not submit proof of income to NYSOH's Appeal Unit as directed.

Your eligibility for Medicaid was effective as of August 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
