Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were ineligible for financial assistance as of October 11, 2017?

Procedural History

On October 10, 2017, you submitted an application for financial assistance through NYSOH. Based on that application, NYSOH rendered a preliminary eligibility determination that you were not eligible for financial assistance.

Also on October 10, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal insofar as were determined ineligible for financial assistance.

On October 11, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a QHP at full cost, effective November 1, 2017. Further, the notice stated that you were ineligible for financial assistance because your household income exceeded the income thresholds for all insurance affordability programs offered through NYSOH.

On December 11, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account and testimony, you are applying for health insurance for yourself.
- According to your NYSOH account and your testimony, you expect to file your 2017 federal income tax return, with a tax filing status of single, and do not expect to claim any dependents on that return.
- 3) According to your October 10, 2017 application, you attested that your 2017 annual household income would be \$74,811.00.
- 4) On December 1, 2017, you submitted a copy of your Unemployment Insurance Monetary Benefit Determination from New York State's Department of Labor to NYSOH. You were determined eligible for a weekly rate of \$430.00, with a claim effective date of September 18, 2017
- 5) You testified that you were issued the following unemployment insurance benefits in the month of October 2017:
 - (a) \$322.50 on October 1, 2017;
 - (b) \$326.25 on October 8, 2017;
 - (c) \$326.25 on October 15, 2017;
 - (d) \$326.25 on October 22, 2017; and
 - (e) \$435.00 on October 29, 2017.
- 6) You testified that you worked at during the month of October 2017. You were issued \$300.00 on October 11, 2017, and October 25, 2017.
- 7) According to your NYSOH account and testimony, you did not expect to claim any deductions on your 2017 federal income tax return.
- 8) According to your NYSOH account, you reside in New York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term "modified adjusted gross income" means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

"Adjusted gross income" means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of finds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income.

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present noncitizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through

the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

Medicaid:

Medicaid can be provided through the Marketplace to adults who: (1) are age 19 or older and under age 65; (2) are not pregnant; (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act; (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part; and (5) have a household modified adjusted gross income that is at or below 138% of the federal poverty for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.603(d)(4)), N.Y. Soc. Serv. Law § 366(1)(b)).

In the case of an individual who expects to file a tax return and does not expect to be claimed by another taxpayer, the household consists of the taxpayer and all persons whom such individual expects to claim as a tax dependent (42 CFR § 435.603(f)(1)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved by the US Department of Health and Human Services, March 19, 2014).

Affordability Exemption

Under some circumstances, a person may receive an exemption from paying a penalty for not purchasing health insurance coverage. Such an exemption may be granted if that person can show that he or she experienced a financial hardship or has domestic circumstances that (1) caused an unexpected increase in essential expenses that prevented that person from obtaining health coverage under a QHP; (2) would have caused the person to experience serious deprivation of food, shelter, clothing, or other necessities, as a result of the

expense of purchasing health coverage under a QHP; or (3) prevented that person from obtaining coverage under a QHP (45 CFR § 155.605(a), (g)).

NY State of Health has deferred to the U.S. Department of Health and Human Services (HHS) on the matter of hardship exemptions (see 45 CFR § 155.505(c)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were ineligible for financial assistance as of October 11, 2017.

APTC are available to a person who is eligible to enroll in a QHP and who expect to have a household income below 400% of the applicable FPL, based on the size of their household.

You expect to file your 2017 federal income tax return, with the tax status of single, and do not expect to claim any dependents on that tax return. Therefore, you are in a one-person tax household for purposes of this analysis.

In the application that was submitted on October 10, 2017, you attested to an annual household income of \$74,811.00, and the October 11, 2017 eligibility determination relied upon that attestation.

An annual income of \$74,811.00 is 629.72% of the 2016 FPL for a one-person household. At 629.72% of the FPL, NYSOH properly determined that your income exceeded the 400% FPL income threshold for APTC. Therefore, you were properly determined ineligible for APTC.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was also \$11,880.00 for a one-person household. Since an annual household income of \$74,811.00 is 629.72% of the 2016 FPL, NYSOH properly found you to be ineligible for the Essential Plan.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size.

On the date of your application, the 2017 FPL applied and was \$12,060.00 for a one-person household. Financial eligibility for Medicaid applicants who are not currently receiving Medicaid benefits may be based on current monthly

household income and family size. For an adult to be eligible for Medicaid in a household of one, their monthly must not exceed \$1,387.00.

The record reflects that you were issued the following UIB in the month of October 2017: \$322.50 on October 1, 2017; \$326.25 on October 8, 2017; \$326.25 on October 15, 2017; \$326.25 on October 22, 2017; and \$435.00 on October 29, 2017. Therefore, you were issued \$1,736.25 in UIB in the month of October 2017.

The record reflects that you worked at during the month of October 2017, and was issued \$300.00 on October 11, 2017, and October 25, 2017. Therefore, you were issued \$600.00 from that employer in the month of October 2017.

Based on the available record, your household income in October 2017 was \$2,336.25. Therefore, your household income exceeded the income threshold for you to be eligible for Medicaid in the month of October 2017.

NYSOH properly determined that you were ineligible for financial assistance as of October 11, 2017.

Decision

The October 11, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

NYSOH properly determined that you were ineligible for financial assistance.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
