Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child's eligibility for and enrollment in her Child Health Plus plan was effective November 1, 2017?

Procedural History

On October 12, 2017, NYSOH issued a notice of eligibility determination, based on your October 11, 2017 application, stating that your child was eligible to enroll in Child Health Plus (CHP) with a \$15.00 monthly premium, effective November 1, 2017.

Also on October 12, 2017, NYSOH issued an enrollment notice, based on your plan selection on October 11, 2017, stating that your child was enrolled in a CHP plan, and that this enrollment in the plan would start November 1, 2017.

On October 17, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's CHP plan insofar as it did not begin October 1, 2017.

On November 27, 2017, NYSOH received (1) a letter from you, dated November 27, 2017, stating why you were appealing the start date of your child's CHP plan coverage, and (2) copies of various medical bills you incurred during the month of October 2017.

On December 7, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your child's eligibility.
- 2) You submitted your initial application to NYSOH for financial assistance on October 11, 2017.
- 3) You testified, and the record reflects, that you enrolled your child into a CHP plan on October 11, 2017.
- 4) You testified that you need your child's CHP plan to begin on October 1, 2017 because you incurred approximately \$450.00 in medical bills relating to her care she received on or about [REDACTED]
- 5) You testified that your child was disenrolled from a CHP plan prior to her enrollment through NYSOH, but you were not sure whether this was through your local department of social services or by directly enrolling through her insurance carrier.
- 6) There is no record of your child's enrollment in a health plan through NYSOH prior to your application received on October 11, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your child’s enrollment in her CHP plan was effective November 1, 2017.

You testified that you contacted NYSOH on October 11, 2017 and enrolled your child into a CHP plan.

You testified that your child was disenrolled from a CHP plan prior to her enrollment through NYSOH, but you were not sure whether this was through your local department of social services or by directly enrolling through her insurance carrier. However, there is no record of your child’s enrollment in a health plan through NYSOH prior to your application received on October 11, 2017.

The date on which a CHP plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Therefore, the October 12, 2017 eligibility determination and enrollment notices stating that your child’s eligibility for and enrollment in her CHP plan was effective November 1, 2017, are correct and must be **AFFIRMED**.

Decision

The October 12, 2017 eligibility determination and enrollment notices are **AFFIRMED**.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility.

The effective date of your child's CHP plan is November 1, 2017.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your appeal was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
