Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Does the NY State of Health (NYSOH) Appeals Unit have the authority to review the cancellation of coverage for a purported non-payment of premiums?

Did NYSOH properly determine that your reenrollment in an Essential Plan was effective December 1, 2017?

Procedural History

On December 14, 2016, NYSOH issued an eligibility determination notice, stating that you were eligible to enroll in an Essential Plan, with a monthly premium of \$20.00, effective January 1, 2017.

Also on December 14, 2016, NYSOH issued an enrollment confirmation notice stating that you remained enrolled in an Essential Plan, effective January 1, 2016.

On October 13, 2017, NYSOH issued a disenrollment notice stating that your coverage in your Essential Plan ended effective September 30, 2017, because you did not pay your insurance bill by the payment deadline.

On October 17, 2017, NYSOH issued a notice of enrollment, based on your plan selection on October 16, 2017, stating that you were enrolled in an Essential Plan, effective December 1, 2017.

Also on October 17, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your Essential Plan insofar as it did not begin October 1, 2017.

On December 7, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing your Essential Plan disenrollment effective September 30, 2017 and your Essential Plan re-enrollment date of December 1, 2017.
- 2) Your NYSOH account reflects that you were enrolled in an Essential Plan with an effective date of January 1, 2017.
- 3) You testified that while you were late with making a payment to your insurance carrier, you were not contacted or notified by the insurance carrier to rectify this non-payment, as had been done twice previously during the 2017 plan year.
- 4) You were disenrolled from your Essential Plan, effective September 30, 2017, for non-payment of premiums.
- 5) You testified, and NYSOH records reflect, that you were again enrolled in an Essential Plan on October 16, 2017.
- 6) Your Essential Plan coverage start date was December 1, 2017.
- 7) You testified that you had a medical bill which was incurred in October 2017.
- 8) You testified that you are seeking the reinstatement of your Essential Plan coverage for yourself during the months of October and November 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (4) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see *also* 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The first issue under review is whether the Appeals Unit of NYSOH has the authority to review the cancellation of coverage for a purported non-payment of premiums.

The Appeals Unit of NYSOH only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) a failure by NYSOH to provide timely notice of an eligibility determination, and (4) a denial of a for a special enrollment period.

Because the Appeals Unit is not authorized to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether you were properly terminated for nonpayment of premiums.

Therefore, your appeal of the October 13, 2017 disenrollment notice is DISMISSED as a non-appealable issue.

The second issue under review is whether NYSOH properly determined that your enrollment in an Essential Plan was effective December 1, 2017.

You testified, and NYSOH records indicate, that you updated your NYSOH application on October 16, 2017. As a result, you were found eligible for an Essential Plan on December 1, 2017 and you selected a plan that day.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On October 16, 2017, you selected an Essential Plan, so your enrollment properly took effect on the first day of the second following month that is, on December 1, 2017.

Therefore, the October 17, 2017 enrollment notice stating that your enrollment in an Essential Plan was effective December 1, 2017 is correct and must be AFFIRMED.

Decision

Your appeal of the October 13, 2017 disenrollment notice is DISMISSED as a non-appealable issue.

The October 17, 2017 enrollment notice is AFFIRMED.

This decision does not change your eligibility.

The effective date of your Essential Plan is December 1, 2017.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your appeal was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
