## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your eligibility for, and enrollment in, an Essential Plan was effective December 1, 2017?

## Procedural History

On October 19, 2017, you created a NYSOH account and filed an application for financial assistance with health insurance. That same day, NYSOH prepared a preliminary eligibility determination, stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective December 1, 2017.

Also on October 19, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your eligibility and enrollment in the Essential Plan, insofar as it did not begin October 1, 2017.

On October 20, 2017, NYSOH issued a notice of eligibility determination, based on your October 19, 2017 application, stating that you were eligible to enroll in the Essential Plan, effective December 1, 2017.

Also on October 20, 2017, NYSOH issued a notice of enrollment, based on your plan selection on October 19, 2017, stating that you were enrolled in an Essential Plan, and that your plan would start December 1, 2017.

On December 11, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record support the following findings of fact:

- 1) You applied to NYSOH for financial assistance with your health insurance on October 19, 2017. Your account confirms that you enrolled in an Essential Plan that same day.
- 2) You testified that your mother submitted this application on your behalf because you [REDACTED] and had to be [REDACTED]. You testified that your mother filed your application on [REDACTED] that you were [REDACTED].
- 3) You testified that you previously had health insurance through your parents, but that this coverage ended when you turned [REDACTED].
- 4) You testified that you thought you had insurance coverage because President Obama said everyone would have insurance and that there would be no issues regarding [REDACTED].
- 5) You testified that you called NYSOH when you found out that your coverage would not start until December 1, 2017, and they told you that you had a [REDACTED] and that there was nothing you could do except file an appeal.
- 6) You testified that you wanted your enrollment in an Essential Plan to begin on October 1, 2017 because you now have medical bills from October, and potentially November 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services

Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/downloads/ny-blueprint.pdf>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## Legal Analysis

The issue under review is whether NYSOH properly determined that your eligibility for, and enrollment in, the Essential Plan, was effective December 1, 2017.

You testified, and the record indicates, that an application for health insurance was filed on your behalf through NYSOH on October 19, 2017. As a result, you were found eligible for the Essential Plan as of December 1, 2017, and enrolled into a plan that day.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On October 19, 2017, you selected an Essential Plan, so your enrollment properly took effect on the first day of the second month following October; that is, on December 1, 2017.

Therefore, the October 20, 2017 eligibility determination and enrollment confirmation notices stating that your eligibility for, and enrollment in, the Essential Plan were effective December 1, 2017, are correct and must be **AFFIRMED**.

It is noted that you testified that you believe you did not receive coverage for October and November 2017 because of some [REDACTED]. There is no evidence in the record that supports this contention. You did not apply for coverage until October 19, 2017. The date on which your coverage started is

based solely on when you filed an application through NYSOH, and your [REDACTED] [REDACTED] at the time had no bearing on the start date of your Essential Plan coverage.

## **Decision**

The October 20, 2017 eligibility determination is AFFIRMED.

The October 20, 2017 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your Essential Health Plan is December 1, 2017, based on when you filed your application through NYSOH.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
