Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your newborn's eligibility for and enrollment in her Child Health Plus plan was not effective as of the date of her birth?

Procedural History

On September 14, 2017, you created a NYSOH account. That same day, you submitted an application for financial assistance for health insurance on behalf of your newborn.

On September 15, 2017, NYSOH issued a notice stating that your newborn was eligible to enroll in Child Health Plus with a \$30.00 monthly premium, effective October 1, 2017.

Also on September 15, 2017, NYSOH issued an enrollment confirmation notice stating that your newborn was enrolled in a Child Health Plus plan, effective October 1, 2017.

On October 19, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's eligibility for and enrollment in her Child Health Plus plan, insofar as it did not begin on the month of her birth.

On December 19, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that your newborn was born on [REDACTED]
- 2) You testified that you are seeking your newborn's Child Health Plus plan to begin as of the first day of the month of her [REDACTED]
- 3) You testified that you want your newborn's Child Health Plus plan to begin on July 1, 2017 because you have out of pocket medical expenses following her birth.
- 4) You submitted an application to NYSOH for financial assistance on behalf of your newborn on September 14, 2017.
- 5) You enrolled your newborn into a Child Health Plus plan on September 14, 2017, which became effective on October 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus - General

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Child Health Plus – Newborns

A newborn child who is eligible for Child Health Plus shall be enrolled retroactively to the first day of the month in which the child is born, provided that the applicant submitted a completed application and required information and documentation within sixty days of the child's birth (NY Public Health Law §2511(2)(i)(i), effective January 1, 2017).

Legal Analysis

The issue is whether NYSOH properly determined that your newborn's eligibility for and enrollment in her Child Health Plus plan was not effective as of the date of her birth.

The record reflects that on September 14, 2017, you created a NYSOH account for your child. That same day, you completed an application for health insurance for your newborn, and enrolled her into a Child Health Plus plan.

In the case of newborns born after January 1, 2017, the newborn will be enrolled retroactively to the first day of the month in which the child was born, provided that the applicant submitted a completed application and required information and documentation within sixty (60) days of the child's birth. If the applicant did not submit a completed application within 60 days of the child's birth, the newborn will become eligible on the first day of the next month, if the application is received by the 15th of the month.

The record reflects that your newborn was born on [REDACTED]. You completed an application for health insurance for your newborn on September 14, 2017. Since an application submitted on September 14, 2017 is more than 60 days from the child's birth, your child is not eligible for retroactive enrollment in her Child Health Plus plan beginning the first day of the month of her birth.

You selected a plan for your newborn's enrollment on September 14, 2017. Therefore, your newborn's Child Health Plus plan properly began on the first day of the month following September 2017; that is, on October 1, 2017.

Therefore, the September 15, 2017 eligibility determination and enrollment confirmation notices are AFFIRMED as they properly began your newborn's eligibility for and enrollment in her Child Health Plus plan as of October 1, 2017.

Decision

The September 15, 2017 eligibility determination notice is AFFIRMED.

The September 15, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your newborn's eligibility.

Your newborn's eligibility for and enrollment in her Child Health Plus plan properly began on October 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
