Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective December 1, 2017?

Procedural History

On October 20, 2017, you created your NYSOH account and submitted an application for financial assistance for health insurance. That day, a preliminary eligibility determination was prepared stating that you were eligible to enroll in Medicaid, effective October 1, 2017. You subsequently enrolled into a Medicaid Managed Care plan.

Also on October 20, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, insofar as it did not begin October 1, 2017.

On October 21, 2017, NYSOH issued a notice of eligibility determination, based on your October 20, 2017 application, stating that you were eligible for Medicaid, effective October 1, 2017.

Also on October 21, 2017, NYSOH issued a notice of enrollment in the plan you selected on October 20, 2017, stating that you were enrolled in a Medicaid Managed Care plan, and that your coverage would start on December 1, 2017.

Finally, on October 21, 217, NYSOH issued a notice stating that you were eligible for Medicaid from September 1, 2017 through September 30, 2017.

On December 19, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted your initial application to NYSOH for financial assistance on October 20, 2017.
- 2) You testified, and the record reflects, that you first selected your Medicaid Managed Care Plan on October 20, 2017, and that your enrollment was effective on December 1, 2017.
- 3) You testified that you want your Medicaid Managed Care plan to begin on October 1, 2017 because you have medical bills for the month of October and your medical provider does not accept fee-for-service Medicaid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Medicaid Managed Care plan was effective December 1, 2017.

On October 20, 2017, you created your NYSOH account and submitted an application for financial assistance. You testified that you then contacted NYSOH on October 20, 2017 and enrolled into a Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On October 20, 2017, you selected a Medicaid Managed Care plan, so it properly took effect on the first day of the second month following after October; that is, on December 1, 2017.

Therefore, the October 21, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan would be effective December 1, 2017, was correct and must be AFFIRMED.

Decision

The October 21, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan is December 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
