Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in an Essential Plan was effective December 1, 2017?

Procedural History

On October 23, 2017, you submitted an application for financial assistance. That day, a preliminary eligibility determination was prepared stating that you were eligible for the Essential Plan, effective December 1, 2017.

Also on October 23, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin October 1, 2017.

On October 25, 2017, NYSOH issued a notice of eligibility determination based on your October 23, 2017 application, stating that you were eligible to enroll in the Essential Plan, effective December 1, 2017.

Also on October 25, 2017, NYSOH issued a notice of enrollment, based on your plan selection on October 24, 2017, stating that you were enrolled in an Essential Plan, and that your plan would start December 1, 2017.

On November 17, 2017, NYSOH issued a notice of plan enrollment, stating that you were enrolled in an Essential Plan and that your plan started October 1, 2017.

On December 12, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified and the record reflects that you enrolled in an Essential Plan on October 23, 2017, with a start date of December 1, 2017.
- 2) On November 15, 2017, incident [REDACTED] was created. That incident reflects that you contacted NYSOH and requested your enrollment in the Essential Plan be made effective October 1, 2017, not December 1, 2017, because you had unpaid medical expenses for the month of October.
- 3) On November 16, 2017, incident [REDACTED] was updated and closed. The incident reflects that NYSOH conducted outreach with your health plan, reinstated your coverage with your plan effective October 1, 2017, and then closed the incident as resolved.
- 4) The record reflects that NYSOH then issued a notice of plan enrollment, dated November 17, 2017, stating that your enrollment with your Essential Plan started on October 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see *also* 42

CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan was effective December 1, 2017.

On October 23, 2017, you submitted an application and were found eligible for the Essential Plan as of December 1, 2017. You subsequently enrolled into a plan.

On November 15, 2017, you contacted NYSOH and incident [REDACTED] was created. That incident reflects that you requested an October 1, 2017 enrollment start date in the Essential Plan because you had unpaid medical expenses for the month of October 2017. On November 16, 2017, incident [REDACTED] was resolved because your health plan restored your enrollment in the Essential Plan effective October 1, 2017.

On November 17, 2017, NYSOH issued a notice of plan enrollment, stating that you were enrolled in an Essential Plan and that your plan started October 1, 2017.

Since NYSOH has conceded the issue of your enrollment state date in your Essential Plan as October 1, 2017, an analysis on the merits of your appeal in this case is not required.

Therefore, the November 17, 2017 enrollment confirmation notice is **AFFIRMED**.

Your case is **RETURNED** to NYSOH to ensure the proper enrollment in your Essential Plan is reflected in your NYSOH account for the period of October 1, 2017.

This decision does not change your eligibility.

You are responsible for any premium payments due as a result of the backdating of your enrollment.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
