NOTICE OF DISMISSAL – FAILURE TO APPEAR

On October 19, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for Medicaid for the month of July 2017. You appealed as you were also seeking Medicaid for the month of June 2017.

On November 29, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for December 19, 2017 at 1:00 p.m. On December 19, 2017, a Hearing Officer called you and initiated the hearing but the telephone call was dropped. The Hearing Officer attempted to re-contact you several times after the dropped call but was unsuccessful. Accordingly, the Hearing Officer returned your case to NYSOH and requested that a new telephone hearing be re-scheduled.

On December 20, 2017, NYSOH issued a new Notice of Hearing to advise you that the hearing was re-scheduled to January 11, 2018 at 3:00 p.m.

On January 11, 2018, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 3:03 p.m., 3:15 p.m., and 3:30 p.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
