Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your children were enrolled in their Child Health Plus plan with an enrollment start date of December 1, 2017?

Procedural History

On March 14, 2015, NYSOH issued a disenrollment notice stating that your children's Child Health Plus coverage was terminated effective April 30, 2014, because the premium payment(s) had not been received by the health insurance company.

On October 26, 2017, your NYSOH account was updated.

On October 27, 2017, NYSOH issued the following notices:

- (1) An eligibility determination notice stating, in relevant part, that your children were eligible for Child Health Plus, each with a \$15.00 monthly premium, effective as of December 1, 2017;
- (2) A plan enrollment notice confirming that as of October 26, 2017, your children were enrolled in a Child Health Plus plan with an enrollment start date of December 1, 2017.

Also on October 27, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal relative to the enrollment start date of your children's health insurance.

On December 20, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken and the record was developed during the hearing. The record was closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified you are appealing the enrollment start date of your children's Child Health Plus plan.
- 2) According to your NYSOH account, your children were born respectively on: [REDACTED].
- 3) You testified that your children have been continuously enrolled in Child Health Plus plan, through NYSOH, for the last couple of years, and their coverage was discontinued as of October 1, 2017.
- 4) You testified that you did not receive any notice from NYSOH or the health insurance company that your children's coverage would be discontinued.
- 5) You testified that you found out that your children's coverage had been discontinued at a medical appointment in October 2017.
- 6) You testified that you contacted Fidelis Care and were informed that your children's coverage had been discontinued because you did not renew their coverage.
- 7) According to the enrollment history in your NYSOH account, your children have not been enrolled in health insurance coverage through NYSOH since April 30, 2014.
- 8) According to your NYSOH account and testimony, you enrolled your children in a Child Health Plus plan on October 26, 2017.
- 9) You testified that you want your children's Child Health Plus coverage to be effectuated for the months of October 2017 and November 2017 to cover the medical expenses that were incurred.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your children’s Child Health Plus plan enrollment start date was December 1, 2017.

The record reflects that your children were determined eligible for Child Health Plus and enrolled in a health plan on October 26, 2017.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since your children’s plan was selected on October 26, 2017, the plan should be effective on the first day of the second month following that date; that is, on December 1, 2017.

Therefore, the October 27, 2017 plan enrollment notice confirming that your child was enrolled in a Child Health Plus plan with a plan enrollment start date of December 1, 2017, is correct and must be AFFIRMED.

During the hearing, you testified that your children have been continuously enrolled in Child Health Plus plan, through NYSOH, for the last couple of years; however, their coverage was discontinued as of October 1, 2017. Further, you contacted Fidelis Care and were informed that your children's coverage had been discontinued because their coverage had not been renewed. Your NYSOH account reflects your children have not been enrolled in health insurance coverage through NYSOH since April 30, 2014.

Your case has been RETURNED to NYSOH's Plan Management Unit to resolve the discrepancy regarding the discontinuance of your children's Child Health Plus coverage and shall notify you of their findings.

Decision

The October 27, 2017 plan enrollment notice is AFFIRMED.

Your case has been RETURNED to NYSOH's Plan Management Unit to resolve the discrepancy regarding the discontinuance of your children's Child Health Plus coverage and shall notify you of their findings.

How this Decision Affects Your Eligibility

The effective date of your child's Child Health Plus plan is December 1, 2017.

Your case has been returned to NYSOH to resolve the discrepancy regarding the discontinuance of your children's Child Health Plus coverage.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
