Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid in April 2017 or June 2017?

Procedural History

On October 17, 2017, you submitted an application for financial assistance with health insurance and indicated that you were seeking help for paying for medical bills for the last three months.

On October 18, 2017, NYSOH issued a notice stating that the income documentation in your application did not match what NYSOH received from state and federal data sources. You were directed to provide proof of your household income by November 1, 2017.

On October 24, 2017, you uploaded income documentation and submitted an updated application for financial assistance with health insurance.

On October 25, 2017, NYSOH issued a notice of eligibility determination stating that you remained eligible for Medicaid. This eligibility was effective as of October 1, 2017.

On October 28, 2017, NYSOH issued a notice stating that you were eligible for Medicaid from July 1, 2017 through September 30, 2017.

On October 30, 2017, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were not determined eligible for Medicaid for the months of April 2017 and June 2017.

On December 20, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open up to January 11, 2018, to allow you to submit supporting documents.

As of January 11, 2018, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid for April 2017 and June 2017.
- 2) You testified that you expect to file your 2017 federal income tax return as qualifying widow, and claim two dependents.
- 3) You testified that you believe you submitted an application for financial assistance with health insurance in July 2017.
- 4) You submitted an application for financial assistance on October 17, 2017. The record reflects that this was the first application submitted in 2017.
- 5) You testified that you received \$1,315.00 in Social Security benefits monthly.
- 6) You testified that you worked from January 2017 to June 2017, and that you earned \$20.00 per hour working 40 hours per week.
- 7) You testified that in April and June 2017, your income was \$3,200.00 per month, and that you also received Social Security benefits.
- 8) You submitted a letter dated July 21, 2017 letter from Social Security Administration, which states that your regular Social Security payment for 2017 is \$1,315.00.
- 9) You testified that you do not plan on taking any deductions on your tax return

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$20,420.00 for a three-person household (82 Fed. Reg. 8831).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid in April 2017 or June 2017.

You are in a three-person household; you file your taxes with a tax filing status of qualified widow and claim two dependents on your tax return.

You submitted an application for financial assistance on October 17, 2017 and requested help in paying for medical bills for the prior three months.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

You testified that you are seeking Medicaid for April 2017 and June 2017.

You testified that you submitted an application for financial assistance with health insurance in July 2017. However, there is no indication in the record that any application was submitted in 2017 prior to October 17, 2017.

Since April 2017 and June 2017 are more than three months prior to your October 17, 2017 application, you are not eligible for Medicaid coverage in those months. NYSOH's October 28, 2017 notice properly stated that you were eligible for Medicaid from July 1, 2017 through September 30, 2017 only it is AFFIRMED.

Decision

The October 28, 2017 eligibility determination is AFFIRMED.

How this Decision Affects Your Eligibility

You are not eligible for Medicaid in the months of April 2017 and June 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This
