## Decision

Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were eligible for Medicaid, effective October 1, 2017?

## **Procedural History**

On October 31, 2017, NYSOH received your initial application for financial assistance with health insurance. That day a preliminary eligibility determination was prepared finding you eligible for Medicaid, effective October 1, 2017.

Also on October 31, 2017, you spoke to NYSOH's Account Review Unit and appealed the preliminary eligibility determination insofar as your Medicaid coverage began on October 1, 2017, and not November 1, 2017.

On November 1, 2017, NYSOH issued an eligibility determination notice, consistent with the preliminary eligibility determination, stating that you were eligible for Medicaid, effective October 1, 2017.

On January 12, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

# **Findings of Fact**

A review of the record supports the following findings of fact:

- According to your NYSOH account and your testimony, you initially applied for financial assistance through NYSOH on October 31, 2017. That day, you were found fully eligible for Medicaid coverage.
- 2) You testified that had you applied for health coverage 14 hours later, you would have still been eligible for Medicaid, but that coverage would have been effective November 1, 2017, instead of October 1, 2017.
- 3) You testified that you wanted your Medicaid coverage to begin on November 1, 2017, because you did not have any medical expenses in October 2017 and you would like your twelve months of Medicaid coverage to end on October 31, 2018 instead of September 30, 2018.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

# Applicable Law and Regulations

## <u>Medicaid</u>

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

# Legal Analysis

It should be noted, that neither your eligibility for Medicaid or the effective date of your Medicaid Managed Care plan is in dispute.

The issue under review is whether NYSOH properly determined that you were eligible for Medicaid starting October 1, 2017.

According to your NYSOH account, and your testimony, you initially applied for financial assistance through NYSOH on October 31, 2017. That day, you were found fully eligible for Medicaid coverage.

Medicaid Fee-For Service coverage is effective on the first day of the month in which that applicant was found eligible for Medicaid. Since you were found eligible for Medicaid on October 31, 2017, NYSOH properly determined that you were eligible for Medicaid, effective October 1, 2017. 2017 eligibility determination notice stating that your eligibility for Medicaid is effective October 1, 2017, was correct and must be AFFIRMED.

The November 1, 2017, eligibility determination notice is AFFIRMED.

# How this Decision Affects Your Eligibility

This decision does not change your eligibility for Medicaid.

The effective start date of your eligibility for Medicaid with coverage in Medicaid Fee-For Service coverage is October 1, 2017.

# If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
