## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child's enrollment in his Child Health Plus plan was effective November 1, 2017?

## Procedural History

On October 12, 2017, your child was added to your NYSOH account and an application for health insurance was submitted on his behalf.

On October 13, 2017, NYSOH issued a notice of eligibility determination, based on your October 12, 2017 application, stating that your child was eligible to enroll in Child Health Plus, effective November 1, 2017.

Also on October 13, 2017, NYSOH issued a notice of enrollment, based on your plan selection on October 12, 2017, stating that your child was enrolled in a Child Health Plus plan, and that his enrollment in the plan would start on November 1, 2017.

On October 31, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your child's Child Health Plus plan insofar as it did not begin on October 1, 2017.

On December 19, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. During the hearing, [REDACTED]

assisted with the hearing. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your child's enrollment start date.
- 2) You submitted your child's initial application to NYSOH for financial assistance on October 12, 2017.
- 3) You testified, and the record reflects, that you enrolled your child into a Child Health Plus plan on October 12, 2017.
- 4) You testified that your child was enrolled in a health plan program prior to enrollment in Child Health Plus through NYSOH. You testified that you did not receive a letter from either your child's healthcare plan or your local Department of Social Services notifying you that your child's healthcare coverage was going to end, and that you needed to enroll your child in health insurance through NYSOH in order to maintain coverage.
- 5) You testified that you enrolled your child into a healthcare plan as soon as you were aware your child did not have healthcare coverage.
- 6) You testified that you did not know your child did not have healthcare coverage until you took your child to a medical appointment and the medical provider informed you that your child no longer had insurance.
- 7) You testified that you need your child's Child Health Plus plan to begin on October 1, 2017 because your child has medical bills for the month of October.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following

such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your child’s enrollment in his Child Health Plus plan was effective November 1, 2017.

You testified that you contacted NYSOH on October 12, 2017 and enrolled your child into a Child Health Plus plan. The record indicates that October 12, 2017 is the first time you listed your child as a household member on your NYSOH account seeking insurance.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected and enrolled your child into a Child Health Plus plan on October 12, 2017, his plan would have probably begun on the first day of the next following month after October; that is on November 1, 2017.

Therefore, the November 1, 2017 enrollment confirmation notice stating that your child’s enrollment in his Child Health Plus plan was effective November 1, 2017, is correct and must be AFFIRMED.

During the hearing, you testified that your child was enrolled in a health plan program prior to enrollment in a Child Health Plus through NYSOH. You testified

that you did not receive any notice from your child's health plan stating that your child's coverage was going to end. You further testified that you enrolled your child into a healthcare plan as soon as you were aware you child did not have healthcare coverage.

NYSOH Appeals Unit has no jurisdiction over proper issuance of notice by plans that are provided outside of NYSOH or through the local Department of Social Services.

## **Decision**

The October 13, 2017 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your child's eligibility.

The effective date of your child's Child Health Plus plan is November 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
