On August 29, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating you were conditionally eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective October 1, 2017. You appealed that determination.

On January 26, 2017, a Hearing Officer from the Appeals Unit of NYSOH called you wherein your spouse indicated that he was representing you at the hearing and he was placed under oath.

While under oath, your representative identified himself and indicated that you were no longer interested in pursuing your appeal, because NYSOH records showed that you had since been determined eligible for Medicaid, effective December 1, 2017, and you were satisfied with that coverage. Your representative stated that you did not have any outstanding medical bills, so the issue under appeal had been fully resolved.

Your representative therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NYSOH will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
