## **NOTICE OF DISMISSAL – FAILURE TO APPEAR**

On November 2, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you are eligible for a tax credit up to \$260.00 per month effective December 1, 2017. This notice further stated that you may be able to enroll in health coverage, if you qualify for a Special Enrollment period. You appealed this determination, in so far as, you did not qualify for a Special Enrollment period.

On January 26, 2018, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 15, 2018, at 3:00 P.M.

On February 15, 2018, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 3:00 P.M., 3:15 P.M., and 3:30 P.M., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

It is noted in your NYSOH account that you attempted to reschedule your hearing for some time after 4:30 P.M. or 5:30 P.M. Please note that all hearings are scheduled for no later than 3:00 P.M.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
