## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your children's enrollment in their Child Health Plus plan is effective December 1, 2017?

## Procedural History

On November 2, 2017, NY State of Health (NYSOH) received your application for health insurance for your children.

On November 3, 2017, NYSOH issued a notice of eligibility determination, based on your November 2, 2017 application, stating that your children were eligible to enroll in Child Health Plus with a \$9.00 monthly premium per child, effective December 1, 2017.

Also on November 3, 2017, NYSOH issued a notice of enrollment, based on your plan selection on November 2, 2017, stating that your children were enrolled in a Child Health Plus plan, and that this enrollment in the plan would start December 1, 2017.

On November 3, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin November 1, 2017.

Also on November 3, 2017, you submitted documentation from your older child's doctor requesting an expedited appeal because of her urgent medical issues.

On November 7, 2017, your request for an expedited hearing was granted.

On November 14, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing your children's enrollment start date for their Child Health Plus plan.
- 2) You testified that your children were previously enrolled in Child Health Plus directly through Excellus Blue Cross Blue Shield.
- 3) You testified that on [REDACTED] or [REDACTED] your older child went to a doctor's appointment and was advised that her insurance had terminated as of October 31, 2017.
- 4) You testified that you contacted Excellus Blue Cross Blue Shield and were advised that your children's coverage had been terminated as you were sent a renewal packet and you failed to respond.
- 5) You testified that you were advised that the renewal packet was sent to a previous address, although your plan was sending bills to your current address.
- 6) You submitted an application to NYSOH for financial assistance on November 2, 2017.
- 7) You testified, and the record reflects, that you enrolled your children into a Child Health Plus plan on November 2, 2017.
- 8) You testified that you need your children's Child Health Plus plan to begin on November 1, 2017 because your older child is in need of [REDACTED].

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your children’s enrollment in their Child Health Plus plan was effective December 1, 2017.

You testified that you submitted an application to NYSOH on November 2, 2017 and enrolled your children into a Child Health Plus plan that day.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

As you selected a Child Health Plus plan for enrollment for your children on November 2, 2017, their plan will properly begin on the first day of the first month following November 2017; that is, on December 1, 2017.

Therefore, the November 3, 2017 eligibility determination notice and the November 3, 2017 enrollment confirmation notice stating that your children’s

eligibility for and enrollment in their Child Health Plus plan was effective December 1, 2017, is correct and must be AFFIRMED.

## **Decision**

The November 3, 2017 eligibility determination is AFFIRMED.

The November 3, 2017 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your children's eligibility.

The effective date of your children's Child Health Plus plan is December 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
