Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly terminate your child from her Child Health Plus plan for non-payment of premium as of July 1, 2017?

Did the NYSOH properly determine that your child's enrollment in her Child Health Plus plan was effective December 1, 2017?

Procedural History

On June 15, 2017, NYSOH received your application for health insurance.

On June 16, 2017, NYSOH issued an eligibility determination notice stating that your child was eligible for Child Health Plus, effective July 1, 2017.

Also on June 16, 2017, NYSOH issued a plan enrollment notice confirming your child's enrollment in Child Health Plus plan, effective July 1, 2017.

On August 10, 2017, NYSOH received your updated application for financial assistance with health insurance.

On August 11, 2017, NYSOH issued an eligibility determination notice stating that your child was eligible for Child Health Plus, effective September 1, 2017.

Also on August 11, 2017, NYSOH issued a plan enrollment notice confirming your child's enrollment in a Child Health Plus plan, effective July 1, 2017.

On August 17, 2017, NYSOH issued a disenrollment notice stating that your child's enrollment in her Child Health Plus plan was terminated, effective July 1, 2017, because a premium payment had not been received by the health plan by the payment deadline.

On November 6, 2017, you contacted NYSOH and enrolled your child in a Child Health Plus plan with an enrollment start date of December 1, 2017.

Also on November 6, 2017, you spoke to NYSOH's Account Review Unit and requested an appeal insofar as your child's Child Health Plus plan was not effective as of July 1, 2017.

On November 7, 2017, NYSOH issued a plan enrollment notice confirming your child's enrollment in a Child Health Plus plan, effective December 1, 2017.

On January 26, 2018, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) Your child was enrolled in a Child Health Plus plan, effective July 1, 2017.
- 2) According to your NYSOH account, your child was disenrolled from her Child Health Plus plan as of July 1, 2017. The August 17, 2017 disenrollment notice states that your child was disenrolled because you did not pay your insurance bill to the health plan by the payment deadline.
- 3) You testified that the Child Health Plus plan did not send you a bill for the premium payments, and that when you called in mid-July 2017, they would not accept a payment over the phone. You testified that you then mailed a check, but that it arrived after the payment deadline.
- 4) You testified that you were not aware that your child had been disenrolled from her plan until **sector** when your child's doctor informed you that she was not covered.
- 5) According to your NYSOH account, you reenrolled your child into a Child Health Plus plan on November 6, 2017.
- 6) According to your NYSOH account and your testimony, your child was without health insurance from July 1, 2017 through November 30, 2017.

7) You testified that you are seeking Child Health Plus coverage for your child, effective July 1, 2017, because you have outstanding bills for medical services rendered.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Appealable Issues

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) a failure by NYSOH to provide timely notice of an eligibility determination 45 CFR § 155.505; and (4) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly terminated your child's Child Health Plus plan for non-payment of premium as of July 1, 2017.

On June 15, 2017, your child's enrollment in a Child Health Plus plan was confirmed, with an effective date of July 1, 2017.

You testified that the Child Health Plus plan did not send you a bill for the premium payments, and that when you called in mid-July 2017, they would not accept a payment over the phone. You testified that you then mailed a check, but that it arrived after the payment deadline. On August 17, 2017, NYSOH issued a notice stating that your child was disenrolled from her Child Health Plus plan for non-payment of the premium, as of July 1, 2017.

NYSOH Appeals Unit only has the authority to review issues related to the following: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions, (3) a failure to provide timely notice of an eligibility determination, and (4) a denial of a special enrollment period.

Since the Appeals Unit is not given the authority to review termination of enrollment due to non-payment of premiums, we cannot reach the merits as to whether your child was properly terminated from her Child Health Plus plan for non-payment of premiums. Therefore, your appeal of the August 17, 2017 disenrollment notice is DISMISSED as a non-appealable issue.

The second issue under review is whether NYSOH properly determined that your child's enrollment in her Child Health Plus plan was effective December 1, 2017.

The record reflects that you contacted NYSOH on November 6, 2017, and enrolled your child into a Child Health Plus plan.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you enrolled your child into a plan on November 6, 2017, health insurance coverage in that plan would properly begin on the first day of the following month after November 2017; that is, as of December 1, 2017.

Therefore, the November 7, 2017 plan enrollment notice stating that your child's enrollment in her Child Health Plus plan was effective December 1, 2017, is correct and must be AFFIRMED.

Decision

Your appeal of the August 17, 2017 disenrollment notice is DISMISSED as a non-appealable issue.

The November 7, 2017 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility for Child Health Plus or enrollment start date.

The effective date of your child's Child Health Plus plan is December 1, 2017.

If You Disagree with this Decision (Appeal Rights)

If applicable, if you think a portion of your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated. NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing. If you do not respond to the dismissed portion of your appeal within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

Insofar as your case was decided, the Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be

appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
